**AGREEMENT FOR SERVICES 454-S1010
AMENDMENT IV**

This Amendment IV to that Agreement for Services 454-S1010, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Willow Glen Care Center, whose principal location is 1547 Plumas Court, Yuba City, CA 95991 (hereinafter referred to as "Contractor"), and whose Agent for Service of Process is Thomas Lee Ortner, 1547 Plumas Court, Yuba City, CA 95991.

RECITALS

WHEREAS, Contractor has been engaged by County to provide residential treatment services for mentally disordered adults, in accordance with Agreement for Services 454-S1010 dated May 25, 2010, Amendment I to that Agreement dated April 6, 2011, Amendment II to that Agreement dated June 14, 2011, and Amendment III to that Agreement dated September 4, 2012, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term to the end of the month, thereby amending **Article II – Term**, increase the not-to-exceed amount of the original Agreement, thereby amending **Article III – Compensation for Services**, and to update contact information, thereby amending **Article XV – Notice to Parties**, and **Article XXIII – Administrator**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services 454-S1010 shall be amended a fourth time as follows:

1) ARTICLE II, shall be amended in its entirety to read as follows:

ARTICLE II

Term: The term of this Agreement shall be for the period of April 15, 2010 through June 30, 2013, unless terminated earlier pursuant to Articles titled "Fiscal Considerations" or "Default, Termination and Cancellation" herein.

2) ARTICLE III, Section 3.08 shall be amended in its entirety to read as follows:

Section 3.08 Total not-to-exceed amount shall be \$540,000 for the term of this Agreement.

3) ARTICLE XIV shall be amended in its entirety to read as follows:

ARTICLE XIV

Notice to Parties: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be addressed as follows:


4) ARTICLE XXIII shall be amended in its entirety to read as follows:

Administrator: The County Officer or employee with responsibility for administering this Agreement is Laura Walny, Acting Program Manager II, or successor.


Except as herein amended, all other parts and sections of that Agreement 454-S1010 and all subsequent Amendments thereto shall remain unchanged and in full force and effect.


