Public testimony will be received on each agenda item as it is called. Individuals will have three minutes to address the Commission. Individuals authorized by organizations will have three minutes to present organizational positions and perspectives and may request additional time, up to five minutes. At the discretion of the Commission, time to speak by any individual may be extended.

Upon completion of public comment on an agenda item, the matter shall be returned to the Commission for deliberation. Members of the public shall not be entitled to participate in that deliberation, or be present at the podium during such deliberation, except at the invitation of the Commission for a point of clarification or question by the Commission.

Hearing to consider Cameron Ranch (Tentative Map Time Extension TM-E22-0007) request for six (6) one-year time extensions to the approved Cameron Ranch Tentative Subdivision Map (TM18-1531) resulting in a new expiration date of December 26, 2028. The property identified by Assessor's Parcel Numbers 102-110-014, 102-110-024, 102-421-001, consisting of 5.6 acres, is located on the east side of Hastings Drive and west of Starbuck Road, approximately 200 to 250 feet north of the intersection with Green Valley Road, in the Rescue area, submitted by CTA Engineering and Surveying; staff recommends the Planning Commission take the following actions:

- 1) Determine that pursuant to the California Environmental Quality Act (CEQA) Guidelines Sections 15162 and 15164, that there is no substantial evidence requiring the preparation of a Subsequent Mitigated Negative Declaration (MND) or an Addendum to the adopted IS/MND, which was adopted by the Board of Supervisors on June 26, 2018; and
- 2) Approve Tentative Subdivision Map Time Extension TM-E22-0007 extending the expiration of the approved Cameron Ranch Tentative Subdivision Map for six (6) years to December 26, 2028, based on the Findings and subject to the original Conditions of Approval as presented. (Supervisory District 4)

**Chair Nevis opened the public hearing and upon conclusion of public comment and staff input, closed the public hearing.**

**A motion was made by Commissioner Payne, seconded by Commissioner Boeger, to accept staff recommendation with item 2 modified to reflect three (1) year time extensions and an end date of December 26, 2025. No action was taken.**

3. [23-0740](#) Hearing to consider Syres Cell Tower Replacement (Conditional Use Permit Revision CUP-R22-0018) request for a Conditional Use Permit Revision to previously approved Special Use Permit S98-0021 to allow for the replacement of an existing cell tower with a monopine cell tower to include an 18.9-foot height increase from 51.1 feet to 70 feet that would allow for collocation of an additional service provider, T-Mobile. The property, identified by Assessor’s Parcel Number 329-162-003, consisting of 4.9 acres, is located on the west side of Panorama Road, approximately 1,000 feet south of the intersection with Mother Lode Drive, in the Placerville area, submitted by Matt Veazey (Agent: T-Mobile); Staff recommends the Planning Commission take the following actions:
- 1) Find Conditional Use Permit Revision CUP-R22-0018 to be Categorically Exempt pursuant to Section 15302, Replacement or Reconstruction, of the CEQA Guidelines; and
  - 2) Approve Conditional Use Permit Revision CUP-R22-0018 based on the Findings and subject to the Conditions of Approval as presented. (Supervisory District 3)

**Chair Nevis opened the public hearing and upon conclusion of public comment and staff input, closed the public hearing.**

**A motion was made by Commissioner Payne, seconded by Commissioner Harkin to:**

- 1) Find Conditional Use Permit Revision CUP-R22-0018 to be Categorically Exempt pursuant to Section 15302, Replacement or Reconstruction, of the CEQA Guidelines; and
- 2) Approve Conditional Use Permit Revision CUP-R22-0018 based on the Findings and subject to the Conditions of Approval as presented.

[23-0435](#) Hearing to consider: Agriculture Department and Planning and Building Department proposed amendments to Title 130 (Zoning Ordinance) of the County Code (OR23-0001) that would amend the Ranch Marketing Ordinance (Zoning Ordinance section 130.40.260) and the Winery Ordinance (Zoning Ordinance section 130.40.400) and staff recommending the Planning Commission recommend the Board of Supervisors take the following actions:
- 1) Recommend the Board of Supervisors approve the California Environmental Quality Act (CEQA) Addendum to the Targeted General Plan Amendment/ & Zoning Ordinance Update (TGPA/-ZOU) Final Environmental Impact Report (FEIR) consistent with Sections 15162 and 15164 of the CEQA Guidelines (Attachment A); and
  - 2) Recommend the Board of Supervisors approve the proposed amendments to the Zoning Ordinance, incorporating additional changes recommended by the Planning Commission on March 9, 2023, and adopt an Ordinance for Title 130 Zoning Ordinance of the El Dorado County Code (Attachment B) based on the Findings as presented by staff.
