Recommendation

Approve the attached budget transfer for \$35,649 from the Bond Authority Capital Project Fund and from General Fund Contingency in the amount of \$48,000 to the Bond Authority Debt Service Fund.

Reason for Recommendation

The Bond Authority Capital Project Fund has a residual balance of \$35,649 that may be transferred to the Debt Service fund.

In addition the Bond Authority Debt Service fund will need an additional contribution from the General Fund Contingency to prevent a cash shortfall by year-end.

Fiscal Impact - There will be a decrease to Contingency in the amount of \$48,000.
