- The committee currently meets quarterly and may require additional meetings if deemed necessary by members of the Committee, Department or Board of Supervisors.

- Provide recommendations to the Board of Supervisors and the Planning and Building Department when current operations or items of interest to the local building industry arise.
- Maintain a full committee roster of members that are committed to the responsibilities set forth in the resolution.
