

AGREEMENT FOR SERVICES 185-S1110  
AMENDMENT II

This Amendment II to that Agreement for Services 185-S1110, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and BHC Sierra Vista Hospital, Inc., a Tennessee Corporation dba Sierra Vista Hospital, Inc., duly qualified to do business in the State of California, whose principal place of business is 8001 Bruceville Road, Sacramento, CA 95823 (hereinafter referred to as "Contractor"), and whose Agent for Service of Process is C. **RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide inpatient mental health services for Clients referred by the County, in accordance with Agreement for Services 185-S1110, dated May 4, 2011, and Amendment I dated October 22, 2012, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to amend **Article III – Compensation**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #185-S1110 shall be amended a second time as follows:

ARTICLE III, Section 3.07 shall be replaced in its entirety to read as follows:

Section 3.07 Total amount of this Agreement shall not exceed \$200,000.

Except as herein amended, all other parts and sections of that Agreement 185-S1110 and any Amendments thereto shall remain unchanged and in full force and effect.
