- See email sent yesterday at 3:40 PM – Jim Mitrisin either incompetent or is willfully violating the law with the blessing of his superiors.

You should be aware by now the 10/19/17 Parks & Recreation Commission meeting was chaired by Kris Payne and attended by Supervisor John Hidahl. The only items on the agenda were the River Management Plan and the Parks & Trails Master Plan. There were only three members of the public in the audience: Nate Rangel, Melody Lane, and Supervisor John Hidahl. I suggest you thoroughly read the attached items I submitted into the public record.

Question is, why did Supervisor Hidahl bother to attend this meeting? After only nine months on the job, it appeared Mr. Hidahl's primary purpose that evening was to applaud Parks & Recreation for what a "great job" they were doing, when in fact staff have been colluding to fraudulently pull the wool over the eyes of the public.

**Supervisor Hidahl:** I hope you observed that Noah Rucker disrespectfully put his head down on the desk in mock despair when I addressed the commissioners and held Kris Payne's feet to the fire for his unethical conduct during last week's Taxpayers Association meeting. BTW, Bernard Carlson has not spoken to Nate Rangel in several years and flatly denied ever being "close friends" with him. To the contrary, Bernard had nothing good to say about Rangel or the American River Conservancy. It is also common knowledge that RMAC has regularly been conducting serial meetings at American River Conservancy, the Nature Center and Camp Lotus. Such meetings are strictly prohibited by the Brown Act. Vickie Sanders reported that the last RMAC meeting held 10/9/17 failed to have a quorum. Although discussion ensued, there were no minutes or an audio recording publicly posted, yet Nate Rangel reported that RMAC rep Adam Anderson "resigned" last month. We still don't know whether the Planning Commission revoked his SUP for the Villa Florentina B&B.

Another particular concern was the misrepresentation by Noel Stack of the Mountain Democrat regarding the 9/26 RMP Update. My photo of the River Mafia Mob was used for her article, but the on-going public safety/retaliation issues I expressed on behalf of District #4 river residents were totally ignored. ***Who exactly is feeding the Mountain Democrat this propaganda??? More importantly, what the hell is going on behind closed doors???***

Note below that due to "equipment malfunction" the Parks & Rec audio was "corrupted" and therefore could not be posted to the EDC calendar. Funny how that so ***conveniently*** happens to be the excuse whenever there are controversial issues involving government transparency and accountability, especially when it concerns the River Mafia Mob and EDC government representatives acting outside of the law (ultra vires). Of equal concern

is the perpetual false RMP information submitted by county staff to the BOS under the apparent direction of County Counsel Mike Ciccozzi.

That is not Good Governance; it is grounds for investigation and disciplinary action.

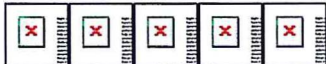
