This Amendment I to that Agreement for Services #067-S0911, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Valentina Reiner, a sole proprietor dba The Law Offices of Valentina Reiner, duly qualified to conduct business in the State of California, whose principal place of business is 2377 Gold Meadow Way, Suite 100, Gold River, CA 95670; (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, Consultant has been engaged by County to provide investigative services and other specialized personnel services on an "as requested" basis for the Human Resources Department, in accordance with Agreement for Services #067-S0911, dated June 24, 2008, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement, hereby amending **ARTICLE II – Term** and **ARTICLE III – Compensation for Services**; and

WHEREAS, the parties hereto have mutually agreed to amend **ARTICLE X – Notice to Parties**; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #067-S0911 shall be amended a first time as follows:

ARTICLE II

Term: This Agreement, as amended, shall become effective upon execution by both parties hereto and shall cover the period of July 1, 2008 through June 30, 2010.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Consultant monthly in arrears. Payment shall be made within thirty (30) days following county receipt and approval of itemized invoice(s) detailing services rendered. For the purposes hereof, the billing rates shall be as follows:

Attorney providing training or investigative services.....\$175.00 per hour
 Paralegal services.....\$50.00 per hour
 Transcription services.....Up to \$5.00 per page

There will be a 0.2 hour minimum charge for each separate item of service. County shall reimburse Consultant for the reasonable cost of long distance telephone calls, mailing, and photocopying at a rate of 2.5% of the gross fees per investigation project.

Reimbursement for mileage, lodging, and meals shall be made in accordance with Exhibit "B", marked "Board of Supervisors Policy D-1", incorporated herein and made by reference a part hereof. Any other travel expense, or any individual travel expense that exceeds \$100.00 must be approved in advance by the Director of Human Resources or designed. County shall compensate for time spent in travel at the hourly rate. The total amount of this Agreement, as amended, shall not exceed \$85,000.00, inclusive of all expenses for the two (2) year period.

ARTICLE X

Notice to Parties: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be addressed as follows:


