



**RESOLUTION NO.**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS, the Recorder/Clerk has studied the costs of operations (e.g. personnel, equipment, etc.) for which the county is not recovering full costs from the public for these services;**
