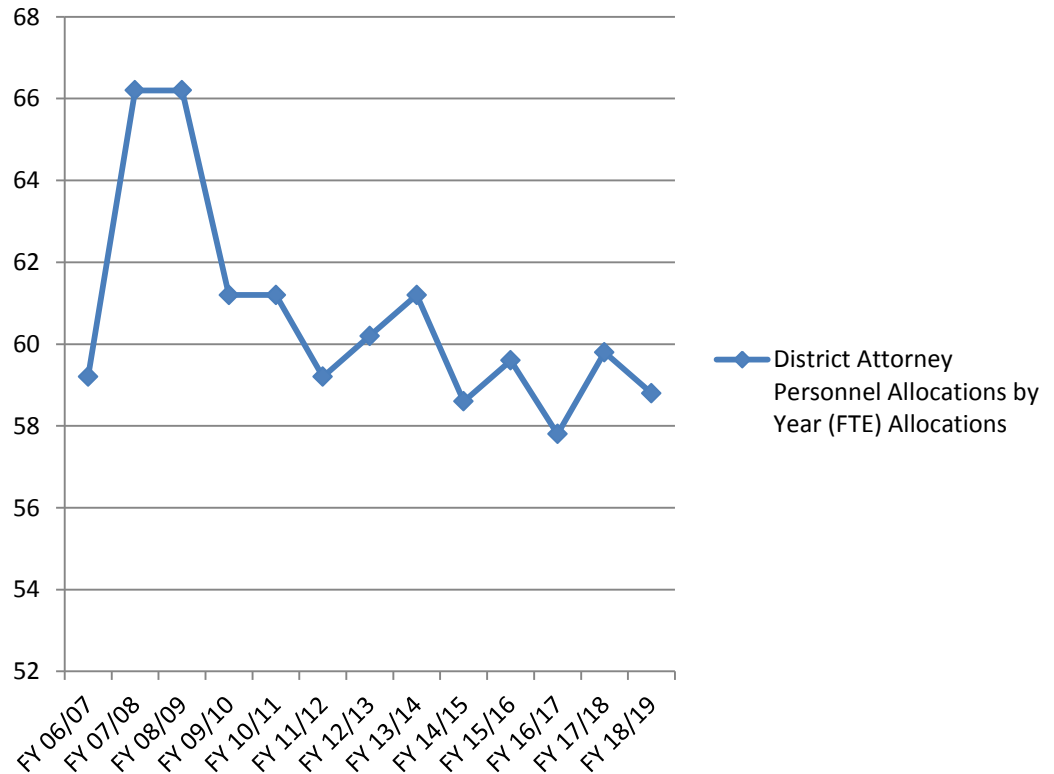

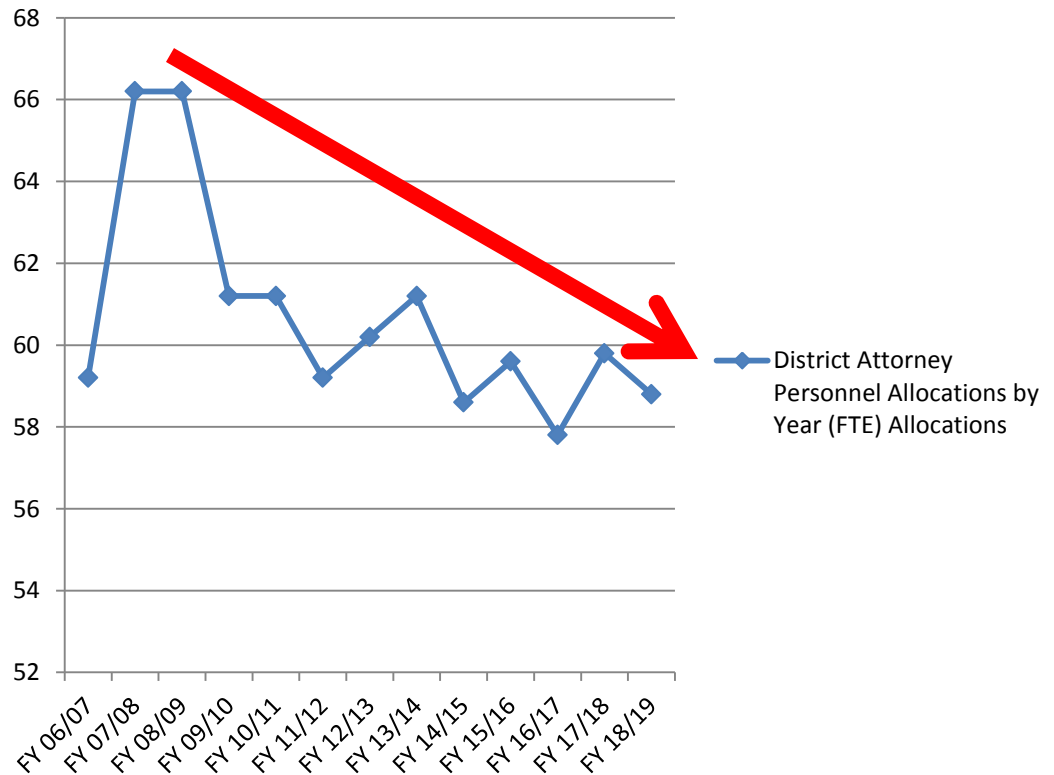

# Criminal Justice System has Changed Dramatically

# Dramatic changes

- **AB 109**
  - Prisoners from CDCR now housed in local jails or released into the community
  - Split sentences: “serving prison time while walking around the streets”
- **Prop 47**
  - Reduced most drug and theft crimes to misdemeanors, regardless of how many prior convictions
- **Prop 57**
  - Reduction in sentences resulting in more prisoners released or never even sent to prison
  - Increased credits earned by all inmates, even violent offenders
- **Prop 64**
  - Reduced punishments for MJ violations and further pushed MJ toward legalization
- **AB 208**
  - Repeated diversion for all drug crimes, regardless of how many times treatment has failed
  - Further pushing towards legalizing Meth, Cocaine, Heroin, PCP



# Crime Trends

- Unincorporated areas of El Dorado County saw **nine** homicides in 2015, a jump of 350% compared to 2014 and 2013.
- The number of reported rapes in unincorporated areas of El Dorado County rose from 33 to 48 between 2014 and 2015, an increase of 45%.
- The number of robberies increased from 23 reports to 32, a jump of 39%.
- In El Dorado County, auto thefts decreased 23%, from 56 reports to 43, between 2014 and 2015
