5. Summary of qualifications related to groups(s). (What experience or special knowledge do you bring to your area of interest?)

I have worked for the South Lake Tahoe Women's Center since June 1999. Prior to being hired at the Women's Center I graduated from UCLA in Psychology and Child Development. While working at the Women's Center, from 1999 – 2002. I provided direct services to families in crisis; provided forensic interviews in suspected molestation cases; and worked very closely with local law enforcement, the District Attorney's office, Barton Hospital and Child Protective Services. addition, I provided Child Abuse Prevention presentations to thousands of children in our local school district and prevention presentations to the general public. Since 2002, I have been the Operations Manager for the Women's Center responsible for the day-to-day operations of the agency, including personnel supervision, grant review and program development. The education and development of children living in South Lake Tahoe is essential to the well-being of our community. Children exposed to domestic violence and child abuse cannot grow up to be happy, healthy adults.

6. Affiliations with professional and/or community groups.

I have been a member of Soroptimist International of Tahoe Sierra since January 2003. From July 2003 – June 2005 I was a member of the Board of Directors in Soroptimist. I am a CASA volunteer (Court Appointed Special Advocate) and have been since 2005. Through Lake Tahoe Community College. I teach Crisis Counseling (COU 111) and have been an Adjunct Faculty member since Fall 2004.

7. Why do you seek appointment?

The Women's Center has participated in this Council for a number of years. Because the focus of the Council is children, and the well-being of children. I think it is important for the Women's Center to be a part of this Council. Domestic violence and child abuse is a growing concern for the families living in South Lake Tahoe. The physical and emotional development of children growing up in violence can be dramatically stunted due to the violence they experience. Child sexual abuse by family members, child care workers, or anyone who interacts with children is a real and dangerous possibility for the children living in South Lake Tahoe. As a member of the El Dorado County Early Care and Education Planning Council, I believe I can speak up for the children living in South Lake Tahoe as I have a genuine interest in their well-being.
