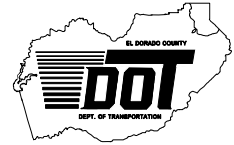

2.01	TH Plan and Sheets SP-144	<p><b>Section 10-1.31 "Temporary Railing"</b>                      Add the following sentence to the end of the third paragraph of this section:  <i>"If at any location the minimum edge distance shown on Standard Plan Sheet T-3 can not be met, pin temporary railing (Type K) in accordance with Section G-G shown on Standard Plan T-3."</i></p>
2.02	SP-153	<p><b>Section 10-1.41 "Earthwork"</b>                      Add the following sentence after the first sentence of the second paragraph on SP-153 :  <i>"The grinding or removal of the temporary paving placed in Stage 0 shall be considered as included in 'Roadway Excavation'."</i></p>
2.03	SP-161	<p><b>Section 10-1.47 "Asphalt Concrete (Type A)"</b>                      Add the following sentence to the end of this section:  <i>"Full compensation for furnishing and placing the temporary paving in Stage 0 shall be considered as included in the unit price bid for Asphalt Concrete (HMA, Type A)."</i></p>


