FIRST AMENDMENT TO AGREEMENT FOR SERVICES #7125

THIS FIRST AMENDMENT to that Agreement for Services #7125 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Stommel Inc, a corporation duly qualified to conduct business in the State of California, whose principal place of business is 4707 Northgate Boulevard, Sacramento, California 95834, (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide law enforcement vehicle tear down and build up services for its Sheriff's Office; pursuant to Agreement for Services #7125, dated January 24, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to add exhibit C, D & E to include the Whelen Automotive List Price, and Setina and Havis Price lists, amending ARTICLE I, Compensation for Services;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

I. **ARTICLE III, Compensation for Services,** Paragraph 2 is amended in its entirety to read as follows:

ARTICLE III

Compensation for Services:

For the purposes hereof, billing shall be on a labor-and-materials basis. The billing rates for materials shall be in accordance with Exhibit B, marked "Stommel, Inc., dba Lehr Auto Electric Proposed Fee Schedule," Exhibit C, marked "Whelen Automotive List Price." discount 40% based on current MSRP, Exhibit D, marked "Setina MFG 2022 Price List," discount 25% based on current MSRP, and Exhibit E marked "Havis" discount 30% based on current MSRP, incorporated herein and made by reference a part hereof. The labor rate shall be \$140 per hour, subject to change upon thirty days prior written notice by Contractor. Any changes to the labor rate shall not affect labor that is part shall proceed in Work Order. which previously approved or а accordance with the terms of such Work Order.

Except as herein amended, all other parts and sections of Agreement for Services #7125 shall remain unchanged and in full force and effect
