After reviewing the County code and General Plan, I write to supplement my earlier public comment.

Pickleball is a use type not previously considered in the Zoning Code and General Plan. The staff report suggests that the use should be regarded as "similar and compatible" to tennis courts and is allowed.

A determination of "similar and compatible" is authorized under the Zoning Code but requires it to be consistent with the General Plan (Zoning Code section 130.20.030 A.3.a.). The General Plan Public Health, Safety, and Noise Element establishes maximum noise standards for non-transportation noise sources adjacent to noise-sensitive land uses, including housing. General Plan Policy 6.5.1.7 requires noise created by non-transportation noise sources to be mitigated so as not to exceed the noise level standards of Table 6-2 for noise-sensitive uses. General Plan Table 6-2 establishes a maximum daytime noise level of 65 dB in Community Regions for recurring impulsive noises. General Plan Policy 6.5.1.10 states: "To provide a comprehensive approach to noise control, the County shall: … C. The zoning ordinance shall be amended to provide that noise standards will be applied to ministerial projects with the exception of single-family residential building permits … "

Like tennis, pickleball is played on a court with a net but with substantially different equipment, including solid surface paddles and rigid plastic balls that produce an intense, recurrent, impulsive noise. The Cameron Park CSD's noise study for the pickleball courts establishes that the impulsive noise generated at the property line of residences adjacent to the pickleball courts exceeds the allowable maximum noise level. Accordingly, further analysis is required on the County's findings that the use for tennis and pickleball is similar and compatible.

In addition, the use intensity increases due to the number of courts and players in the same area. In the area of three tennis courts that would typically accommodate six players, there are eight pickleball courts with room for thirty-two players, which impacts the intensity of use and the number of parking spaces required. A significant social aspect of pickleball involves loud dialogue between players and those waiting for a court.

Adding pickleball to the Zoning Code as an allowed use should be a legislative matter, where decisionmakers can consider the impacts and establish appropriate standards and permitting requirements to minimize those impacts on adjacent property owners.
