**SEVENTH AMENDMENT TO SERVICE AGREEMENT #471-S1211**

**THIS SEVENTH AMENDMENT** to that Service Agreement #471-S1211 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "Customer"), and GovernmentJobs.com, Inc., a corporation duly qualified to conduct business in the State of California, doing business as NEOGOV, whose principal place of business is 2120 Park Place, El Segundo, California 90245, (hereinafter referred to as "NEOGOV").

**R E C I T A L S**

**WHEREAS**, NEOGOV has been engaged by Customer to provide software and related services for the Human Resources Department pursuant to Service Agreement #417-S1211 dated January 27, 2012, First Amendment to Service Agreement #471-S1211, dated March 13, 2018, Second Amendment to Service Agreement #471-S1211, dated August 19, 2019, Third Amendment to Service Agreement #471-S1211, dated June 30, 2020, Fourth Amendment to Service Agreement #471-S1211, dated June 21, 2021, Fifth Amendment to Service Agreement #471-S1211, dated May 12, 2022, and Sixth Amendment to Service Agreement #471-S1211, dated April 20, 2023, all incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to update the annual subscription fee for Fiscal Year 2024-2025 to \$83,345.26, and add Addendum VII to Exhibit A, Sigma Upgrade Order Form, for the period of July 1, 2024 through June 30, 2025;

**WHEREAS**, the parties hereto desire to amend the Agreement to update Article 15, California Levine Act, and correctly reflect the Article number as 18, and include an updated Levine Act Statement, adding **Exhibit B-1, Updated California Levine Act Statement**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, Customer and NEOGOV mutually agree to amend the terms of the Agreement in this Seventh Amendment to Service Agreement #471-S1211 on the following terms and conditions:

- I. Exhibit A, Sigma Upgrade Order Form**, of the Agreement is amended to add Addendum VII to Exhibit A, for the period of July 1, 2024 through June 30, 2025; all prior Order Forms shall expire and be of no further force or effect as of July 1, 2024.

**II. Article 15, California Levine Act, has been renumbered and is replaced in its entirety to read as follows:**

**18. California Levine Act.** Pursuant to Government Code section 84308 (SB 1439, the Levine Act), NEOGOV shall complete and sign the attached Exhibit B, marked "California Levine Act Statement," and Exhibit B-1, marked "Updated California Levine Act Statement," both incorporated herein and made by reference a part hereof, regarding campaign contributions by NEOGOV, if any, to any officer of Customer.

Except as herein amended, all other parts and sections of Service Agreement #471-S1211 shall remain unchanged and in full force and effect.

**Updated California Levine Act Statement**

**California Levine Act Statement**

California Government Code section 84308, commonly referred to as the "Levine Act," prohibits any officer of El Dorado County from participating in any action related to a contract if he or she accepts, solicits, or directs any political contributions totaling more than two hundred and fifty dollars (\$250) within the previous twelve (12) months, and for twelve (12) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract. The Levine Act also requires disclosure of such contribution by a party to be awarded a specific contract. An officer of El Dorado County includes the Board of Supervisors, any elected official, and the chief administrative officer (collectively "Officer"). It is the NEOGOV's responsibility to confirm the appropriate "Officer" and name the individual(s) in their disclosure.
