## FIRST AMENDMENT TO AGREEMENT FOR SERVICES #8874

THIS FIRST AMENDMENT to that Agreement for Services #8874, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and The Center for Violence-Free Relationships, a nonprofit public benefit corporation duly qualified to conduct business in the State of California, whose principal place of business is 344 Placerville Drive, Suite 11, Placerville, California 95667 (hereinafter referred to as "Contractor").

#### RECITALS

WHEREAS, Consultant has been engaged by County to assist its District Attorney's Office in providing the equivalent of one (1) full-time Sexual Assault Counselor to work specifically with victims of sexual assault and their families on cases presented to the District Attorney's Office pursuant to Agreement for Services #8874, dated August 8, 2024, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of September 30, 2025, for one (1) additional year, amending ARTICLE II, Term;

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-toexceed compensation amount of the Agreement by \$64,968, amending ARTICLE III, Compensation for Services;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #8874 on the following terms and conditions:

I. ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

#### **ARTICLE II**

Term: This Agreement shall become effective when fully executed by the parties hereto and shall cover the period of October 1, 2024, through September 30, 2026.

II. ARTICLE III, Compensation for Services, of the Agreement is amended in its entirety to read as follows:

## **ARTICLE III**

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears. Payment shall be made within forty-five (45)

days following County's receipt and approval of itemized invoices detailing the services rendered.

For the purposes hereof, the billing rates shall be in accordance with the following:

The billing rate shall not exceed \$5,354 per month for counseling services.

County will also reimburse up to \$60 per month for a mobile phone stipend and data allowance for the Sexual Assault Counselor during the term of the Agreement. The mobile phone stipend and data allowance are to ensure the swift facilitation of the on-line victim application process while in the field. Requests for reimbursement shall be made monthly and shall be itemized on the monthly invoice. No back-up documentation shall be required for the reimbursement of the mobile phone stipend or data allowance.

The total amount of this Agreement, as amended, shall not exceed \$129,936, inclusive of all costs, taxes, and expenses.

Itemized invoices shall follow the format specified by County and shall reference this Agreement number on their faces. Copies of documentation attached to invoices shall reflect Contractor's charges for the specific services billed on those invoices.

or to such other location as County directs.

In the event that Contractor fails to deliver, in the format specified, the deliverables required by this Agreement, County at its sole option may delay the monthly payment for the period of time of the delay, cease all payments until such time as the required deliverables are received, or proceed as set forth below in ARTICLE XIII, Default, Termination, and Cancellation, herein.

Except as herein amended, all other parts and sections of Agreement for Services #8874 shall remain unchanged and in full force and effect.
