2. Provide the background of events leading to this acquisition.
Department of Transportation, Maintenance and Operations Division has been using identical parts/cabinets with signals. The parts are necessary to ensure the back up power systems for signals are operational when power outages are experienced. County signal technicians have the experience and expertise allowing them to identify the parts and system required for County signal development and maintenance.
3. Describe the uniqueness of the acquisition. (Why was the goods/services supplier chosen?)
The product and supplier were chosen to maintain consistency throughout the County traffic signal intersections and be able to accommodate all necessary required devices. When maintaining consistency it allows staff and consultants to have the necessary expertise with that fuel cell system to repair the equipment when needed.

If the items are not purchased through Western Systems, Inc., DOT would experience a variety of equipment in the field of would have to replace infrastructure at various signals that would not meet the needs and requirements for traffic signal devices. Cabinets are required to hold and protect all electrical components for traffic signals, preventing tampering and environmental factors from altering the systems functionality.
