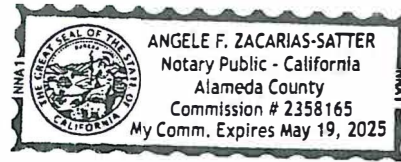

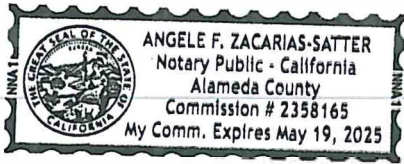

Irrevocable Offer of Dedication  
Road Right of Way

All that real property situate in the County of El Dorado, State of California lying in the East One-half of the Southeast One-quarter of Section 35, Township 10 North, Range 9 East, M.D.M. and being a portion of Lot LL-4 as shown on the "Large Lot Final Map of La Caille Estates", filed in Book K of Subdivision Maps, Page 4, Official Records of El Dorado County and being more particularly described as follows:


BEGINNING at a point on the East line of said Lot LL-4, said point marked by a 5/8" rebar with aluminum cap stamped LS 5914 and being the Northwest corner of Lot 18 as shown on the plat of "La Caille Estates Unit No.1", filed in Book K of Subdivision Maps, Page 19, Official Records of El Dorado County; thence from said POINT OF BEGINNING, leaving said East line and along the arc of a curve, concave to the Northeast, having a radius of 490.00 feet, the chord of which bears North 60°53'46" West, 31.51 feet to a point on the West line of said Lot LL-4; thence along the West line of said Lot LL-4, North 21°47'59" East, 33.10 feet to the Northwest corner of said Lot LL-4 and from which a survey spike and washer stamped LS 5914 bears North 62°01'51" West, 12.90 feet; thence along the North line of said Lot LL-4, South 62°01'51" East, 20.82 feet to the Northeast corner of said Lot LL-4; thence along the East line of said Lot LL-4, South 04°56'56" West, 36.44 feet to the POINT OF BEGINNING, containing 0.020 acres, more or less.

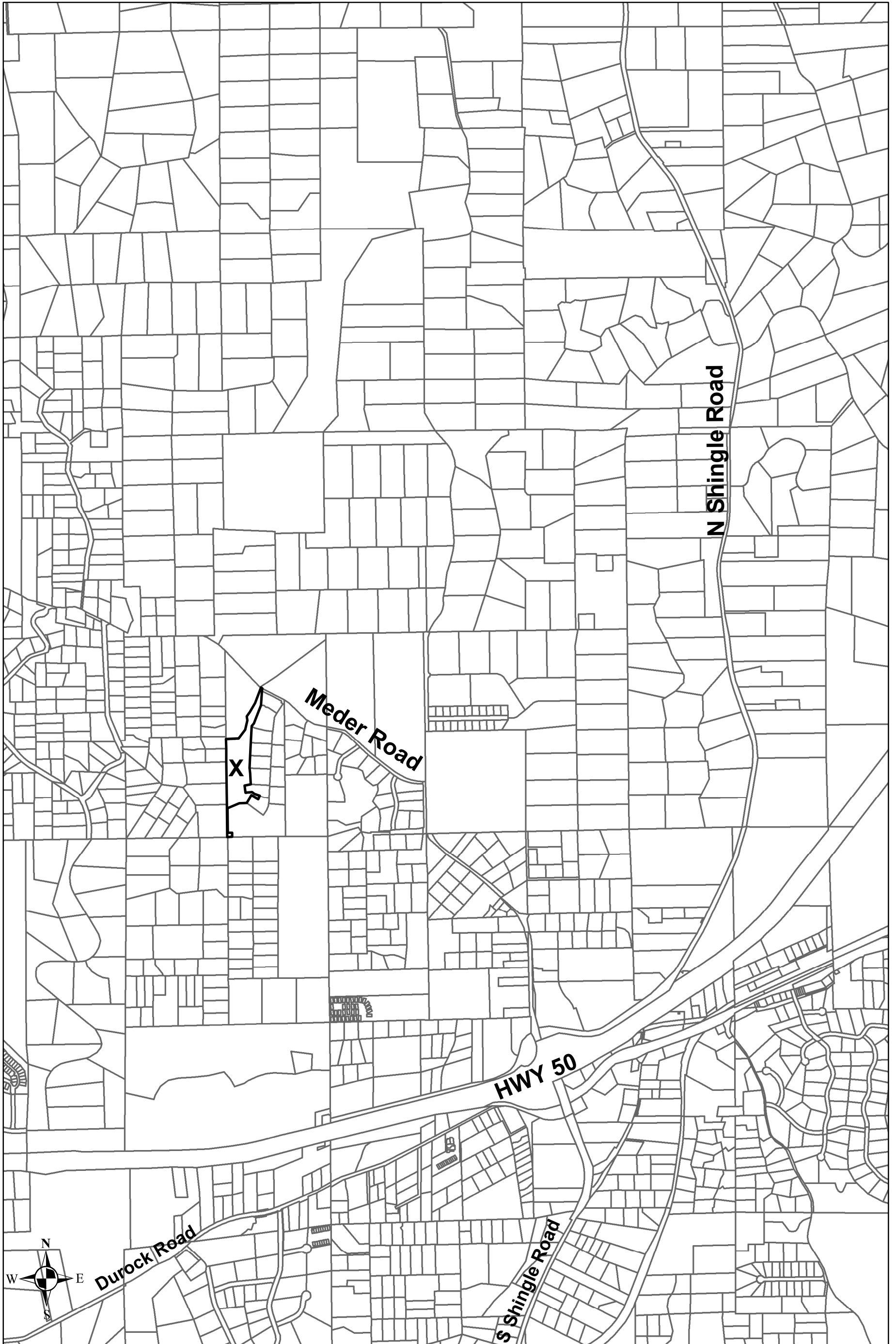

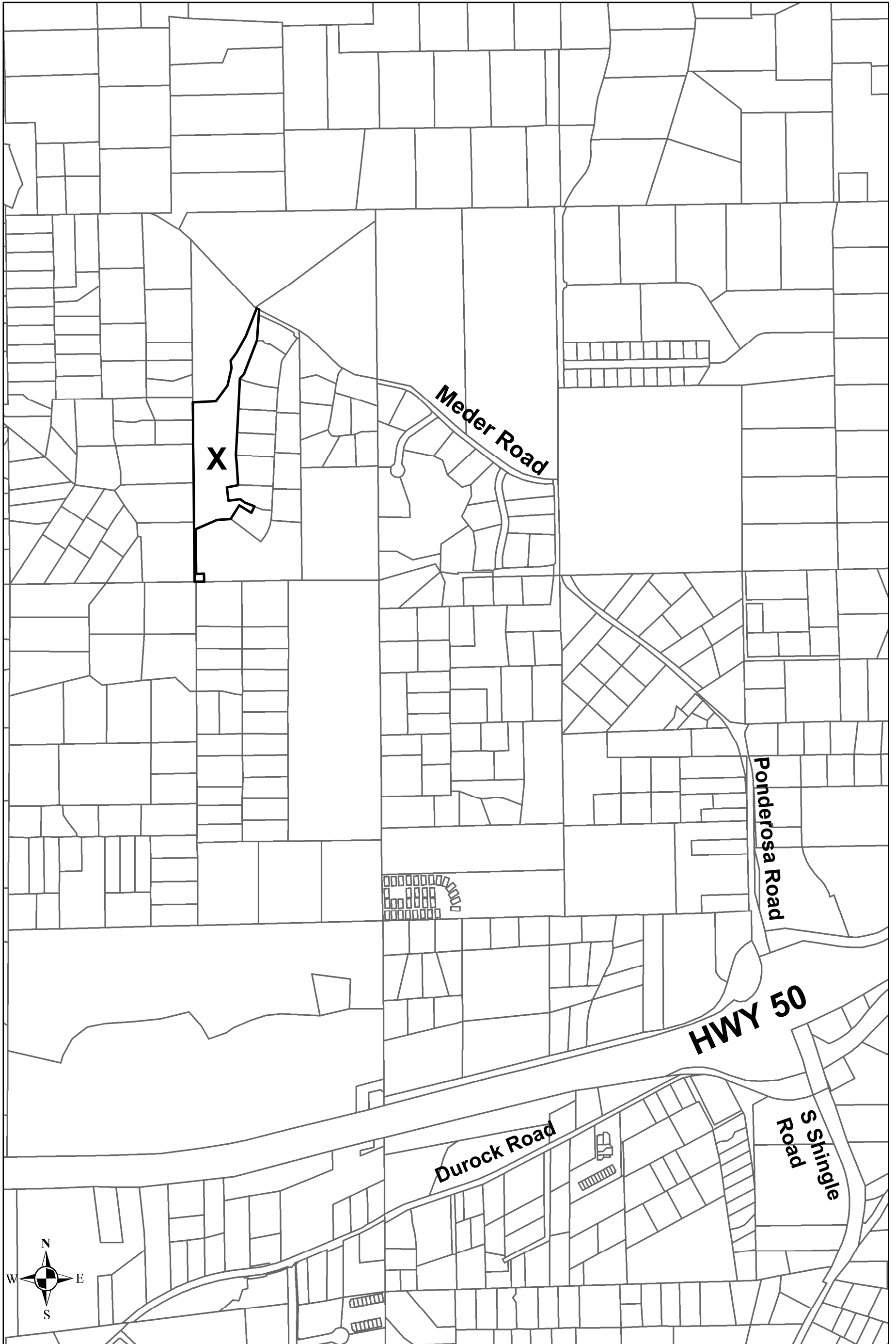
