The County of El Dorado Board of Supervisors will hold a public hearing in the Supervisors Meeting Room, 330 Fair Lane, Placerville, CA 95667 on April 24, 2018, at 2:00 p.m., to consider a request submitted by Roland and Penny Brecek appealing the Planning and Building Department Director's February 22, 2018, approval of Grading Permit number 263768. The permit consists of grading, fill retaining walls, driveways, and site preparation for construction of a single family residence. The property, identified by Assessor's Parcel Number 110-460-61, consisting of 1 acre, is located on the west side of Guadalupe Drive, approximately 0.5 mile west of the intersection with Francisco Drive, in the El Dorado Hills area, Supervisorial District 1.
