PROTOCOLS FOR PUBLIC COMMENT

Individual Committee members may ask clarifying questions but will not engage in substantive dialogue with persons providing input to the Committee.

If a person providing input to the Committee creates a disruption by refusing to follow Committee guidelines, the Committee Chair may take the following actions:

Step 1. Request the person adhere to Committee guidelines. If the person refuses, the Committee Chair may turn off the speaker's microphone.

Step 2. If the disruption continues, the Committee Chair may order a recess of the Committee meeting.

Step 3. If the disruption continues, the Committee Chair may order the removal of the person from the Committee meeting.

[22-0413](#) Cameron Park Design Review Committee recommending as a result of ongoing concerns related to COVID-19, approve the following finding pursuant to Government Code subsection 54953(e)(3) in order to allow for the continued use of virtual or hybrid Cameron Park Design Review Committee meetings as authorized under Assembly Bill 361: Pursuant to Government Code subsections 54953(e)(3)(A) and (e)(3)(B)(ii), the Cameron Park Design Review Committee has reconsidered the circumstances of the Governor's proclaimed state of emergency resulting from COVID-19 and finds that the El Dorado County Public Health Officer continues to recommend measures to promote social distancing, as documented in the September 30, 2021 "Public Health Officer's Recommendations for Safe Board and Commission Meetings During COVID-19 Pandemic".

3. [22-1216](#) DR22-0002 - Tumble Time II (DG Granade, Inc./Joseph Nielsen & Dave Ochoa/Jon N. Westphal): A Design Review Permit request for a proposed 15,000-square foot commercial building including 12,400-square feet of gym floor, and an 800-square foot dance studio, for the purpose of leasing the building to an existing gymnastics instruction facility. The property, identified by Assessor's Parcel Number 082-411-003, consists of 1.05 acres, and is located on the north side of Greenwood Lane, approximately 500 feet north of the intersection with Knollwood Drive, in the Cameron Park area, Supervisorial District 2.
4. [22-1221](#) PA22-0004 - Country Club Apartments (Arcadia Whitney Investments, Inc./Mooni Sanwal): An SB35 Pre-Application request for a 192-unit fully affordable housing apartment development consisting of one, two, and three bedroom units and associated site improvements for parking, landscaping, and resident amenities. The property, identified by Assessor's Parcel Number 082- 430-005, consists of 15.82 acres, and is located south of the intersection between Country Club Drive and Royal Drive, in the Cameron Park Community Region.
