DESCRIPTION OF THE PROJECT The work done is described in the Special Provisions and shown on the Plans, and generally consisted of, but was not limited to: construction of Class 1 shared use trail with 10-foot wide paved path with 2-foot aggregate base shoulders, precast concrete boardwalk system, tubular steel railing, and a prefabricated bridge (approximately 12 feet wide and 110 feet long) over Trout Creek. Construction also includes clearing and grubbing, tree removal, excavation and grading, asphalt concrete paving, drainage improvements, bridge abutments, signing and striping, pavement markings, revegetation, dewatering, traffic control, and temporary erosion control.		
LOCATION OF PROJECT: The Phase 1B portion of the Project begins at Glenwood Way near Becka Drive, through Bijou Meadow towards Al Tahoe Boulevard between the Bijou Bike Park and the Pioneer Village subdivision; the Phase 2 portion begins at Sierra Boulevard and continues along Barbara Avenue and crosses Martin Avenue towards Trout Creek and continues west of Meadow Crest Drive and connects to the existing shared use trail near Lake Tahoe Community College, in the City of South Lake Tahoe in the County of El Dorado.
