On November 5, 2019, the Board approved a budget amendment to move funding from the Sheriff's Department budget to the Facilities budget to pay for the janitorial contract at the new Sheriff's facility. The transfer that was attached to the item at approval did not include the project strings for the Sheriff's Department accounts. The attached budget transfer does not change the general ledger org, objects, or amounts. The only revisions are on lines 2 through 4 adding the project string information.
