NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and NEOGOV mutually agree to amend the terms of the Agreement in this Fifth Amendment to Service Agreement #471-S1211 on the following terms and conditions:

- I. Section 14, Administrator, of the Agreement is amended in its entirety to read as follows:
 - **14. Administrator:** The County Officer or employee with responsibility for administering this Agreement is Joseph Carruesco, Director, Human Resources Department, or successor.

II. Exhibit A, Sigma Upgrade Order Form, of the Agreement is amended to add Addendum V to Exhibit A, for the period of July 1, 2022 through June 30, 2023; all prior Order Forms shall expire and be of no further force or effect as of July 1, 2022.

Except as herein amended, all other parts and sections of Service Agreement #471-S1211 shall remain unchanged and in full force and effect.
