**FIRST AMENDMENT TO AGREEMENT FOR SERVICES #8070**

**THIS FIRST AMENDMENT** to that Agreement for Services #8070, made and entered by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Fostering Connections, A Professional Licensed Clinical Social Worker Corporation, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 941 Spring Street, Suite #5 and/or #7, Placerville CA 95667, and whose Agent for Service of Process is Stephen J. Yun, 2612 Cleat Lane, Sacramento CA 95818, (hereinafter referred to as "Consultant");

**RECITALS**

**WHEREAS**, Consultant has been engaged by County to provide the Probation Department with sex offender counseling to certain clients of the Probation Department, in accordance with Agreement for Services #8070, dated October 18, 2023; incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to increase the not-to-exceed amount of the Agreement, hereby amending **ARTICLE III – Compensation for Services**;

**NOW THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement #8070 on the following terms and conditions:

**I. ARTICLE III, Compensation for Services, Paragraph Three**, of the Agreement is amended to read as follows:

The total amount of this Agreement shall not exceed \$125,802.00, inclusive of all costs, taxes, and expenses.

Except as herein amended, all other parts and sections of that Agreement #8070 shall remain unchanged and in full force and effect.




