I certainly do have a few questions of Supervisor Ranalli. It is his responsibility to respond to each of the following issues, in writing, prior to the 7/26 PC meeting:

- 1) Why did it take 2 emails apprizing more than two dozen government representatives, PLUS a phone call to Brenda Bailey, before my 7/5/18 comments were finally publicly posted to the 7/26 Planning Commission agenda?
- 2) Mike Ranalii is my elected District #4 Supervisor. When I spoke with Brenda on 7/12 I asked for a written explanation from your office about the delay in posting these public comments to the 7/26 PC Consent agenda item #2. The appearance is that there is a hidden agenda and lack of government transparency and accountability. Why have your written explanations to inquiries not been forthcoming?
- 3) For what reason(s) was the 7/9/18 RMAC meeting suddenly cancelled at the eleventh hour on 7/9/18?
- 4) The BOS has been apprised that Nate Rangel publicly admitted his role in getting his cohort, Adam Anderson, appointed by the BOS as the RMAC Business Representative. Rangel also twice publicly announced in 2017 that Anderson had resigned from RMAC. Furthermore, Anderson publicly admitted, in his own words, to "legal manipulations" in order to remain as the RMAC Business Rep. Under whose authority were those "legal manipulations" conducted?
- 5) Rangel & Anderson have regularly conducted chaotic serial RMAC meetings, **many of which are held in the Marshall Gold Discovery Park**. Serial meetings are strictly prohibited by the Brown Act. RMAC--as well as government staff--have continued to  **censor public input, falsified documents, threatened river residents, and blatantly lied** to the Parks & Rec and Planning Commissions. For decades RMAC has demonstrated they are out of control. So why are the BOS ignoring the FACTS, thereby aiding and abetting unlawful serial RMAC meetings, and encouraging the Planning Commission to rubber-stamp Consent item #2?
- 6) The CAO announced in a memo dated 5/9/17 that RMAC would likely be disbanding by the end of 2017 (see attached), yet the RMAC is still intact and operating "ultra vires" (outside of the law) as publicly reported in the Mountain Democrat by Larry Weitzman: <http://www.mtdemocrat.com/opinion/the-balancing-act-disbanding-river-management-advisory-committee/> WHY is the BOS permitting RMAC to perpetually operate outside of the law???
- 7) For what reason were Vickie Sanders, Serena Carter and Noah Triplett cc'd on Char's email?
- 8) EDC professes "The Gold Standard in Public Service." So please explain, in detail, why you've deviated from "good governance" policies and failed to be responsive to constituent concerns and CPRAs concerning RMAC?

Please post these public comments to the July 9<sup>th</sup> RMAC agenda and to the July 26<sup>th</sup> Planning Commission agenda. Note the objections to the illegitimacy of these agenda items for the following reasons:

- RMAC fails to be transparent or accountable. It is a matter of public record that Nate Rangel has referred to RMAC on several occasions as “his” committee. It is a fact that Mr. Rangel also has a penchant for holding serial RMAC meetings in the **Marshall Gold Discovery Park**, Camp Lotus and at American River Conservancy. **Serial meetings are strictly prohibited by the Brown Act.**
- It is also a matter of public record that RMAC continues to operate outside of the law and entirely for their own special interests. River residents have **never been properly represented by RMAC** in the 20 years I’ve lived in Coloma. Regarding EDC's lack of compliance with CPRAs, you've been apprised that we've gone round and round this merry go round before in meetings with Robyn Drivon, Paula Franz, Kim Kerr, Pam Knorr, Don Ashton, Roger Trout, Jim Mitrisin, and Mike Ranalli. It was I who provided them with the **Guide to CA Public Records Act Requests**.

It is apparent that I'm more knowledgeable about CPRA laws than County Counsel. I did not ask to *view* any records, nor is there any lawful requirement that I access them via the dysfunctional government system. ***Everyone knows the Sheriff has ordered IT to blacklist me, making certain individuals and information inaccessible.*** Therefore I requested they be **emailed to me in a readable, condensed format as they have been in the past.** It is perfectly acceptable, consistent with Government Code, much more time efficient and cost effective for everyone.

The county has complied with these requests before, but it is evident Counsel chooses not to. Apparently they didn't teach you too much in law school, so here's a little basic refresher course:

My taxes pay your salary, therefore you work for me. Ditto for the BOS, Don Ashton and the COB to whom the CPRAs are addressed. **County Counsel is *not* the authorized spokesperson for any government official outside of a courtroom.**

Regarding EDC's lack of compliance with CPRAs, you've been apprised that we've gone round and round this merry go round before in meetings with Robyn Drivon, Paula Franz, Kim Kerr, Pam Knorr, Don Ashton, Roger Trout, Jim Mitrison, and Mike Ranalli. It was I who provided them with the **Guide to CA Public Records Act Requests**.

It is apparent that I'm more knowledgeable about CPRA laws than County Counsel. I did not ask to *view* any records, nor is there any lawful requirement that I access them via the dysfunctional government system. ***Everyone knows the Sheriff has ordered IT to blacklist me, making certain individuals and information inaccessible.*** Therefore I requested they be **emailed to me in a readable, condensed format as they have been in the past.** It is perfectly acceptable, consistent with Government Code, much more time efficient and cost effective for everyone.

The county has complied with these requests before, but it is evident Counsel chooses not to. Apparently they didn't teach you too much in law school, so here's a little basic refresher course:

My taxes pay your salary, therefore you work for me. Ditto for the BOS, Don Ashton and the COB to whom the CPRAs are addressed. **County Counsel is not the authorized spokesperson for any government official outside of a courtroom.**

Regarding Mr. Runkle's comment about not being obligated to respond to questions or provide specific public documents, that's BALONEY. It is inconsistent with Government Code, is unethical, against all public policy, and lacks transparency or accountability.

EDC advertises "***The Gold Standard in Public Service.***" Unnecessarily charging Citizens for records that can be delivered electronically is called Unjust Enrichment. Deliberately falsifying or withholding public information is Fraud. This would especially apply to Roger Trout, Joe Harn and Bill Schultz. Refusing to respond to constituents demonstrates your contempt for your Constitutional Oaths of Office and the law, proof that EDC has established a new ***Standard for CA Corruption.***
