The property, identified by Assessor’s Parcel Number 046-710-017, consisting of 46.53 acres, is located on the north side of D’Agostini Drive, approximately 1 mile west of the intersection with Mount Aukum Road, in the Somerset area, submitted by Michael Pinette; Staff recommends the Planning Commission take the following actions:
- 1) Adopt the Mitigated Negative Declaration (MND) based on the Initial Study prepared by staff;
 - 2) Adopt the Mitigation Monitoring and Reporting Program (MMRP) in accordance with the California Environmental Quality Act (CEQA) Guidelines Section 15074(d), incorporated as Conditions of Approval; and
 - 3) Approve Commercial Cannabis Use Permit CCUP21-0004 based on the Findings and subject to the Conditions of Approval as presented. (Supervisory District 2) (Cont. 3/28/24)

Chair Nevis opened the public hearing and upon conclusion of deliberation and staff input, closed the public hearing.

A motion was made by Commissioner Williams, seconded by Commissioner Nevis to accept the staff recommendation from the 3/27/24 memo to continue the project off calendar to allow for the preparation of an Environment Impact Report (EIR) or allow the applicant to revise their project to address public comment concerns and testimony.
