



## RESOLUTION NO.

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, in accordance with Government Code 25502.3, in counties with a population less than 200,000, the board of supervisors may authorize the purchasing agent to engage independent contractors to perform services for the county or county officers, with or without the furnishing of material, when the aggregate cost does not exceed fifty thousand dollars (\$50,000); and

**WHEREAS**, the authorized purchasing agent amount shall be adjusted annually by any annual increase in the California Consumer Price Index as determined pursuant to Section 2212 of the Revenue and Taxation Code; and

**WHEREAS**, the County of El Dorado began calculating its purchasing agent's authority to engage independent contractors to perform services in accordance with Government Code 25502.3 in Fiscal Year 2008, increasing the authority each year in accordance with the California Consumer Price Index; and

**WHEREAS**, an audit performed in 2023 to verify historic calculations revealed a calculation error that occurred in 2009; and

**WHEREAS**, the calculation error was carried forward and compounded each of the following years; and

**WHEREAS**, the Chief Administrative Office, Procurement and Contracts Division has corrected the purchasing agent authority to comply with Government Code 25502.3 and compiled a list of active service contracts that exceed the corrected calculated amount; and

**WHEREAS**, Board of Supervisors authorization is required for each of the active contracts that exceeds the purchasing agent authority; and

**WHEREAS**, the list of one-hundred-twenty-nine (129) active contracts that exceed the purchasing agent authority is attached hereto.

**NOW, THEREFORE, BE IT RESOLVED**, that the County of El Dorado Board of Supervisors does hereby authorize the service contract amounts that exceed the purchasing agent authority in the year they were executed as identified by the spreadsheet attached hereto.
