



## RESOLUTION NO.

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, California Business and Professions Code, Section 13350, authorize the Board of Supervisors of the County of El Dorado to adopt legal regulations to authorize the El Dorado County Agricultural Commissioner/Sealer of Weights and Measures to establish a schedule of fees not to exceed the costs incurred for the services provided; and

**WHEREAS**, California Business and Professions Code, Sections 12210, 12210.5 and 12240, authorize the Board of Supervisors of the County of El Dorado to adopt legal regulations to authorize the El Dorado County Agricultural Commissioner/Sealer of Weights and Measures to establish a schedule of fees not to exceed the costs incurred for the services provided; and

**WHEREAS**, California Business and Professions Code Section 13350 authorizes the County to adopt an ordinance to inspect point-of-sale systems, and authorizes the County to establish an annual registration fee, , and a re-inspection fee; and

**WHEREAS**, Proposed Chapter 5.55 of the County Ordinance Code will establish a regulatory program for the County Sealer to register and inspect automated point-of-sale systems, and will authorize the Board, via resolution, to establish the amount of the applicable fees; and

**WHEREAS**, the County Sealer has reviewed similar fees adopted by similar jurisdictions and determined the updated fees do not exceed the reasonable costs to the County Sealer for providing this service; and

**WHEREAS**, the fees in the attached schedule (Exhibit A) have been reviewed for statutory limits set forth in the code sections referenced above and all applicable limits have been incorporated into the fee schedule therein; and

**NOW THEREFORE, BE IT RESOLVED**, the Board of Supervisors hereby adopts the following attached schedule of fees (Exhibit A) for use by the El Dorado County Department of Agriculture, Weights and Measures; and

**BE IT FURTHER RESOLVED**, that the fees contained in the attached Fee Schedule (Exhibit A) shall be reviewed annually by the Department of Agriculture, Weights and Measures and revised in accordance with Board of Supervisors' Policy; and

**BE IT FURTHER RESOLVED**, that the El Dorado County Department of Agriculture, Weights and Measures Fees shall become effective July 01, 2026; and

**BE IT FURTHER RESOLVED** that this resolution will upon adoption by the Board of Supervisors; supersede Resolution Number 082-2025, 393-2006 and 022-2013.
