 - d) Approve and sign the Construction Contract, subject to final review and approval by County Counsel and Risk Management; and
 - e) Authorize the Community Development Agency Director (or designee) to sign an Escrow Agreement, if requested by the Contractor and in accordance with Public Contract Code Section 22300, for the purpose of holding Contract retention funds;
- 3) For the projects listed in Attachment A, authorize a 10-day advertisement for construction bids;
- 4) Pursuant to Public Contract Code section 22050, find that the projects listed in Attachment A will not permit a delay resulting from a typical competitive solicitation for bids, and that the implementation of these projects is necessary to respond to the emergency (4/5 vote required); and
- 5) Authorize the Community Development Agency, Transportation Division to place \$75,000 from the Road Fund into an escrow account that can be used jointly to pay for Right of Way needs of all emergency projects. (Est. Time: 1 Hr.)

FUNDING: Recommended options to pay for the projects being the Risk Management Fund and/or Tribal Funds, which will be repaid after Federal and State reimbursements have been obtained.
