Subject Proposal to eliminate the entire General Fund contribution to the Senior Day Care Center

Dear Supervisors,

I understand through a fax sent to my office by Ms. Demarest dated 10/28/10 that due to budgetary constraints, the County is considering completely eliminating the Senior Day Care Center's contribution from the General Fund.

I have no specific knowledge of the Center's finances, but I would not find it difficult to believe that the loss of these funds could result in the closure of the Center.

As a local business owner and public school parent, I am quite sensitive of the need for very difficult decisions to be made regarding the apportionment of increasingly limited funds.

However, as a local family doctor I would respectfully point out that the Center is a uniquely valuable resource to our community. It provides an affordable, safe and healthy environment for our increasingly aged population and especially for those with Alzheimer's dementia. Often, this Center allows my elderly patients to remain in their own homes with the care of their spouses, children and other friends and family. When I describe the Center as unique I mean that there is no comparable service for such patients. Assistance with meals and home care exist, but this is the only service that provides a place for our elders to socialize and also allows caregivers and family a chance to work, attend to other needs or to have some respite from providing care around the clock. Without this, many families will have no other choices but permanent institutionalization or more frequent hospitalization.

I urge you to allow the Center to continue to provide such a valuable service to our community and to our elders, to whom we owe a debt of duty, respect and gratitude.



It has come to my attention that the Board of Supervisors is considering cutting funds to the Senior Day Care Center and the Senior Legal Services, among other Senior programs. I have been volunteering at the Senior Day Care Center for a number of years and see the value of this program in giving respite to the caregivers of these seniors with dementia. At this program, they receive the chance to socialize, participate in stimulating activities, enjoy music and stories, and have a fuller life. But the most important benefit of this program is the respite the time spent at the Senior Day Care Center gives to the caregivers who then have a chance to rest, maintain friendships, do errands, etc. Please reconsider cutting funding to this program as it is vital to the lives of many seniors who would otherwise be isolated at home with only their caregiver for company.

And, as one who has benefitted from the Senior Legal Services, I am very impressed with what small staff accomplishes. They are indeed a dedicated group of individuals and are often the only source for legal services that our senior citizens have. I often brag about the wonderful services that our seniors have available to them in El Dorado and know that is why many of them have moved here. Please consider your priorities carefully as it is these very senior citizens who made these programs possible when they were the wage earners in our county. It seems very unfair to take the services away from these individuals.

Dear Board Members:

We would like to express our sadness at the thought of loosing the Senior Day Care Program in El Dorado County. Our 86 year old stepfather has attended the Day Care program 5 days a week, for over a year.

When we first brought him into our home, he was diagnosed with dementia, he was malnourished, came from an anti-social environment. He didn't know what year it was, what month, day, season, etc. He had been under his son's care, whom had been neglecting him, financially, socially and nutritionally.

My husband and I both work full time and didn't know what we were going to do with him, as his physician said he needed 24-hr care. We looked into the community options and decided on the El Dorado Senior Day Care program. That program was like a gift from God. Not only does my step-father look forward to getting up every morning, he gets up, showers (didn't do that before), eats a healthy breakfast, socializes all day with his friends at day care, and leads a much more productive life. The Senior Day Care was the best medicine we could have found for him.

He has been under our care for over a year now and has gained 40 pounds, knows what day it is, season, and month. He looks forward to each day and I feel one of the greatest reasons for this is because of the socialization from the Senior Day Care. The caring workers and volunteers from this program are one the greatest programs El Dorado has to offer. Please reconsider the cut of this program.

Please, I urge you, please don't let down our seniors. They need this program so desperately, as well as their caregivers.
