RESOLUTION OF VACATION**

**Abandonment of Easement #07-0021  
Parkview Heights Unit No. 3, Lot 95  
Assessor's Parcel Number 125-563-01**

**Ronald D. Kenzy, Trustee, and Rosalie Kenzy, Trustee of the  
Kenzy Family Revocable Trust dated 5/19/99**

**WHEREAS**, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

**WHEREAS**, public utility easements, as shown on the Parkview Heights Unit No. 3 final map, were irrevocably offered in perpetuity to the County of El Dorado in August of 1988 and accepted by the Board of Supervisors in February of 1989; and

**WHEREAS**, the Department of Transportation has received an application from Ronald D. Kenzy, Trustee, and Rosalie Kenzy, Trustee of the Kenzy Family Revocable Trust dated 5/19/99, owners of Lot 95, identified as Assessor's Parcel Number 125-563-01, requesting that the County of El Dorado vacate public utilities easements located along the westerly and southerly boundary lines of Lot 95; and

**WHEREAS**, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easements for the purpose for which they were dedicated or acquired; and find that no present or future need exists for said easements and do not object to their vacation; and

**WHEREAS**, all other existing easements will remain; and

**WHEREAS**, the Department of Transportation has determined that said easements herein described in Exhibit "A" and depicted in Exhibit "B", and made a part hereof, have not been used for the purpose for which they were dedicated preceding the proposed vacation, and has no objection.

**NOW, THEREFORE BE IT RESOLVED**, that from and after the date this Resolution is recorded, said public utilities easements described in Exhibit "A" and depicted in Exhibit "B" are vacated and no longer constitute public utilities easements. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
