The full APAC reviewed the subcommittee's report for this project at our July 8<sup>th</sup> regular meeting. APAC voted unanimously 4-0 in favor of <u>Conditional support</u> for the project due to safety concerns expressed relative to the Green Valley Road right-in/right out only provision without a planned acceleration lane being added on Green Valley Road. This is a similar situation to the Francisco Village entrance on Green Valley Road (immediately to the East of this project), which APAC ultimately supported, once the acceleration lane was required by DOT. The two noted concerns from the subcommittee report below still apply:

- The project plans only show 29 designated parking spots, 2 of which are for handicapped only. This seems inadequate for a 64 room facility with all of the associated staff and visitors that would be expected.
- 2) The circular drive around the facility provides good on-site circulation and access for emergency vehicles, provided that cars (overflow or convenient access use) are not allowed to park on the side of the drive. APAC therefore recommends that the signs and curb markings prohibiting parking on the sides of the drive be required.
