### Concerns/objections to the traffic study submitted by the applicant parcel:

- The traffic study fails to account for the potential need for a mass evacuation during a fire emergency given that there is a single access road to the property.
   Can 75 vehicles exit onto Highway 193 at the same time in an emergency evacuation?
- The submitted study does not appear to include analysis of the critical intersections at Tegra Road and Brush Rocks Lane, the primary eastern access points to Highway 193 near Black Oak Winery. More notably, it does not address potential safety concerns associated with the entrance location, which is situated between blind curves on a high-speed highway with limited sight lines due to steep terrain. In my view, this configuration presents inherent risks, as vehicles navigating these curves may have insufficient visibility to respond safely to queues forming at the winery entrance—particularly during events.
  - As a resident with direct observation of current operations, I have observed that Highway 193—especially when large party buses are involved—can experience congestion and maneuvering challenges. I believe approving increased activity without a thorough, site-specific safety assessment during an actual event may overlook safety implications for highway users. It is my opinion that safety considerations must be prioritized.
- In addition the traffic study was submitted before the applicant increased the number of events to 165 annually. As far as I can tell from the file on eTRAKIT, there is not a supplemental traffic study submitted. The traffic study also relies on video and drone drive-thru and as far as I can find does not include any real time observations from the engineering firm of traffic activity or impacts, including when venue staff, vendor staff, and guests for events arrive and when these same passenger vehicles depart onto Highway 193 at the end of the event.
- Have any experts, hired by the applicant or peer reviewing for the county, been present during an event to observe traffic impacts during an event in real time?

#### Concerns/objections to the sound study submitted by the applicant parcel:

- Regarding the updated sound study dated 7/14/25, several statements stood out to me.
  On page 2, it notes that "an increase of 10 dBA is generally perceived as doubling in
  loudness," and on page 4, it states, "There is no completely satisfactory way to measure
  the subjective effects of noise or the corresponding reactions of annoyance and
  dissatisfaction." These points highlight that any noise—amplified or not, whether from
  human voices, live bands, or whistles—that exceeds the ambient sound level in our rural
  residential area can significantly impact residents.
- Given that our nighttime baseline is approximately 30-35 decibels, I would argue that even noise levels of 40-45 decibels could provoke an adverse response.
