



# RESOLUTION NO. 111-2010

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, the County of El Dorado is submitting an application for Federal Aviation Administration (FAA) funding allocated to the remediation of a potentially unsafe condition located west of the Georgetown Airport Runway 16-34, consisting of use of onsite dirt used to fill a large hole at the edge of the runway safety area.

**WHEREAS**, the FAA requires local government approval authorizing the application and availability of the 5% matching funds for that portion of the project costs which are not to be paid by the FAA.

**WHEREAS**, in order to meet the FAA's time constraints to obtain grant funding, the Department of Transportation signed the grant application pursuant to authority granted by Resolution No. 198-2008.

**NOW, THEREFORE, BE IT RESOLVED**, the El Dorado County Board of Supervisors:

1. Acknowledges the Director of the Department of Transportation's designee's signing of the grant application, submission of the application for \$155,500 in FAA funding, and authority to provide additional information as may be required by the FAA; and
2. Authorizes accepting the allocated funds for the project at the Placerville Airport; and
3. Certifies it has sufficient funds available for the required 5% matching funds for that portion of the project costs which are not to be paid by the FAA; and
4. Certifies the project will comply with all applicable Federal laws, regulations, executive orders, policies, guidelines, and requirements as they relate to the application; and
5. Certifies it has the legal authority to apply for the grant, finance and carry out the proposed project, and maintenance operation, including contribution of matching funds; and
6. Certifies that El Dorado County holds title for the property known as the Georgetown Airport; and
7. Certifies that it will comply with all assurances contained in the grant application.
