

Dear Supervisors and CAO:

First of all, even though my husband and I relocated over 2 years ago, it does not mean that our hearts and concern for our home for over 2 decades in Pollock Pines is not still very much alive in our hearts. We are speaking for the many residents and businesses that have been working on the Playground and subsequently the Forebay Park for over 9 years. Please also know that we both stepped down from the CEDAPP Board after moving to Indiana; however CEDAPP continues to bring business to the businesses of Pollock Pines by the many annual activities they continue to host.

It's taken me these several days since I was advised about your decision to take away the money that had been awarded to us to be able to write to you regarding the tragic loss of the grant money (\$3 million) we received about 4 years ago in order to bring Pollock Pines the playground that so many of the Pollock Pines residents and businesses, as well as other supporters from elsewhere in the county invested their time, treasure and talent for the past 9 years of collaboration, design, community meetings, fundraisers, etc., supposedly in partnership with EDC.

For me, the issue is twofold - the money and timing:

Both the Board of Supervisors and the EDC Parks and Recreation Commission approved the \$3 million Prop 68 grant to our Forebay Project stating we were the only community in EDC that did not have a public playground for its children or family members for healthy outdoor activities. We were also told repeatedly in videoed county meetings that we were the only qualifier for the grant because of its focus. It then became a matter of using that money for the adjoining park as well. I'm just not understanding how that grant money that was received with the sole purpose of creating a playground and park for Pollock Pines could just be taken away. Aren't there standards that apply to the conditions of the grant? I, and I'm sure others, would be very interested in seeing the actual grant (Prop. 68) as it was submitted and the response received upon its award.

As I am reflecting back now, sadly, we were also disapproved by the CAO from submitting our own application for Proposition 68, citing the possibility of a perception of competition. He would not sign the required signature for our application, even though it was completed after many hours of effort by two of our community members. The belief was that if the county did not get the grant (as had been the sad fact previously) we might have an even

greater chance given the nature of the grant. In any event, it would go right back to the county...because that's the way government works. "Our" playground - we always knew would belong to the county no matter how much work, time or money we would put into it ourselves...but that was ok with us. We just wanted our children and families to have a public playground like other communities. The playground was designed by the community to compliment the natural and historic surroundings of that locale.

This endeavor began in January 2016. CEDAPP, and later the Pollock Pines Playground People, worked together with the county to get the designs done correctly and on time while fulfilling all of the obligations required by all government agencies. This was done. What was not done brings me to the second issue.

What was not done all along the way was timely, appropriate action-based responses to begin the work on the playground/park. Despite meetings and persistent communications with the powers that were in place at the time (some still are), month after month and ultimately, year after year, there was no movement towards beginning the actual construction of the then approved designs as were created by the community residents and businesses in Pollock Pines. There were constant changes of direction brought before us. Even so, we continued to work with the county in getting the job done. The design was focused on retaining the rustic (Nature's Wonderland), historic atmosphere of our community, and a plan to also assist the school with historic lessons and businesses by bringing more people to the community who would then use the opportunity to visit some of our local eateries and other businesses. It was as much economic as it was recreational for all ages and all abilities. No other public playground in EDC had an ALL ABILITIES playground, another significant factor of our plan.

To repeat: money and timing. If the county had responded in a timely manner several years ago, we would not be in this position now. And our children and families would have a beautiful, unique, historic playground and source of economic development.

The question that has not been answered is...Who is responsible for a \$20 million deficit?! This deficit has caused several projects to be canceled, not just ours. Because of this shortfall, however, we can't even hire a full time librarian for the Pollock Pines Library. How much more of our community do you want to keep stripping away? When will our community become a priority for any of you? I have to ask the community of Pollock Pines; "Do you deserve to always be put in last place by EDC powers that be?" When my husband and I first moved to Pollock Pines in 2002 and I became the principal at Sierra Ridge Middle School, I was told by someone who had lived in the community all her life and had been involved in organizational decisions for her adult life, that PP had always been the "bastard child of the county." I didn't want to believe it at the time and even while going through so

many setbacks regarding the development of our playground, I still didn't believe it. But this latest piece takes my breath away and now I wonder about the truth of that statement from almost 25 years ago.

Getting back to the timing issue - another important question: Does a \$20 million deficit happen overnight? Why has there been no transparency about this since it began? And when did it begin? And why have there been no measures to address it, at least not that we, the community, knows of? Is there a reason it came about as an unexpected giant bombshell for everyone, not just Pollock Pines? People can deal with quite a lot if they just know the issues and can understand and count on effective actions. To do less than that is to disrespect your own constituency.


To all Pollock Pines residents and businesses, I am so sorry that our great expectations in delivering a fantastic playground has been stolen from you. The CEDAPP Board and the Pollock Pines Playground People are all heartbroken. We grieve right alongside you. But there is a need for transparency. I'm not sure any of it can be justified, but perhaps a more complete understanding might help.

I guess the next question is...what can happen next regarding getting a public playground for the youth and families of Pollock Pines? I also have to wonder why, if my information is correct, has there not been a replacement for me (District 5) on the Parks and Recreation Commission. It has been approximately 27 months since I stepped down from the Commission. Why has there been no one to keep our community at the table?

Again, I am fully aware of all of the cut-backs and destroyed projects, not just ours, but where are the answers? Where is the hope?

Dear CAO Schmid and Board of Supervisors;

I am trying to understand your process in cutting costs from the county budget. I'm probably not alone.

There was the 3 hour discussion of the DTOT in March, in which several categories of cuts were proposed.

Then, last week, April 8th, there was a 27 page power point presentation on more proposed budget cuts. How were the suggested budget cuts selected from the overall county budget? Why were so many suggested cuts from HHSA? It's the job of the CAO's office to come with this proposal, along with the input of Budget Ad Hoc committee of Supervisor Veercamp and Board Chair Turnboo. True?

Then it was said April 8th that if the proposed budget cuts met the \$15M (or is it \$20M?) goal, then the other county departments may not be called on to bring forward their proposed savings measures. What's he logic in that? Wouldn't you want to see the whole picture of what each department could do in cost saving measures and then decide of all the savings options available, which to choose to meet or exceed your intended goal?



Creating a place-based thriving rural economy that generates prosperity for working lands businesses, landowners, rural people and the county through thoughtful and efficient land-use policies, expanded property opportunities, streamlined processes and financing mechanisms of mutual community benefit.

Rooted to Rise envisions a diverse and symbiotic multi-conomy that brings outdoor recreation. agriculture, connected trails systems, experience economy, gathering venues, rural lodging and other sustainable compatible uses that preserve our beloved land and watershed while providing critical revenue to the county and its rural working people.
