Activity Report
January 1, 2024 to June 30, 2024

January 22, 2024 (3 hours)

One deputy patrolled the trail from El Dorado Station to Camino and back to EDSO. A lot of foot traffic. El Dorado Station, Old Depot Bike Park, there were approximately 60 people observed on the trail, but there were no issues noted.

February 26, 2024 (4 hours)

One deputy patrolled the trail from El Dorado Sheriff's Office to Latrobe and back to EDSO. It was a warm day on the trail. Just a handful of people walking on the MBX Trail. The trail is still muddy and flooded in multiple areas. No Issues or anything unusual was noted.

March 8, 2024 (3 hours)

One deputy patrolled the trail from El Dorado Sheriff's Office to Camino and back to EDSO. Very busy morning on the trail. One citizen concerned about a "well established" transient camp just off trail. Attempted to contact but no one present. There were approximately 100 people on the trail.

March 15, 2024 (3 hours)

One deputy patrolled the trail from El Dorado Sheriff's Office to Amber Fields and back to EDSO. Approximately 30 people were observed on the trail. Few contacts on paved trail. XP at El Dorado Station. Light use. No violations were observed. Spoke with several subjects and educated them about trail usage.

April 1, 2024 (3 hours)

One deputy patrolled the trail from the El Dorado Sheriff's Office to Camino and back to EDSO. Busy last day of Spring Break on the trail! A lot of walkers, cyclers, and families. XP at El Dorado Station, Placerville Station, Old Depot Bike Park. No issues. There were approximately 100 people observed on the trail.

April 25, 2024 (4 hours)

Patrolled the paved section of the trail from the Sheriff's Office to Camino-Shingle Springs. No violations noted. There were approximately 25 trail users encountered.

May 8, 2024 (3 hours)

One deputy patrolled the trail from El Dorado Sheriff's Office to Camino and back to EDSO. A lot of foot traffic, XP El Dorado Station, Old Depot Bike Park, approximately 60 people were observed on the trail. There were no violations observed.

May 13, 2024 (8 hours)

Two deputies patrolled the trail from El Dorado Sheriff's Office to Latrobe then back to EDSO. Approximately 10 people observed using the trail, light traffic on the MBX Trail. XP at El Dorado Station. No issues or violations observed.

June 5, 2024 (3 hours)

Patrolled the paved section of the trail from the Sheriff's Office to Camino and back. Several contacts on the trail. People appreciated EDSO presence. No violations or issues observed. There were approximately 50 trail users encountered.

June 11, 2024 (3.5 hours)

One deputy patrolled the trail from El Dorado Sheriff's Office to Camino and back to EDSO. 2 electric bikes on trial. 1 walker. 1 transient female sleeping on a bench at Lock Bridge/ referred to the HOT Team. Trail between El Dorado Station and Missouri Flat Road is overgrown. No issues or violations observed.

June 13, 2024 (3 hours)

One deputy patrolled the trail from El Dorado Sheriff's Office to Camino and back to EDSO. One transient attempting to set up camp. Was arrested then cite released for an active warrant per on duty Sergeant. There were approximately 8 people observed on the trail. No other issues noted.

June 19, 2024 (3.25 hours)

Patrolled the paved/dirt trail from the Sheriff's Office to Shingle Springs and back. Slow evening with only a few subjects walking/riding bikes. No violations observed on the trail. There were approximately 10 trail users encountered.
