

RESOLUTION NO. 030-2025

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Child Welfare Services California-Child and Family Services Review System Improvement Plan

WHEREAS, in January 2004, the implementation of California Assembly Bill (AB) 636 (Chapter 678, 2001) brought a new Child Welfare Services (CWS) Outcome and Accountability System to California, also known as the California-Children and Family Services Review (C-CFSR), that monitors local Child Welfare Services and Juvenile Probation strategies and their effects on child outcomes in all California counties;

WHEREAS, the C-CFSR includes several processes that all California counties must participate in, and which are overseen by the State of California Department of Social Services (CDSS) including Quarterly Outcome and Accountability Data Reports, Peer Review, County Self-Assessment (CSA). System Improvement Plan (SIP), and Annual SIP Updates;

WHEREAS, the CDSS has combined the Child Abuse Prevention, Intervention and Treatment (CAPIT)/ Community-Based Child Abuse Prevention (CBCAP)/ Promoting Safe and Stable Families (PSSF) Three-Year Plan with the SIP and, which is overseen by its Office of Child Abuse Prevention (OCAP), with the SIP;

WHEREAS, the SIP is a five-year operation agreement between the county of jurisdiction and CDSS, document, which outlines the framework that the county of jurisdiction, through its Probation Juvenile Services (Probation) and Child Welfare Services programs, will improve outcomes for children, youth, and families and includes specific strategies, timeframes, and outcome measures in the areas of safety, permanency, and child and family well-being;

WHEREAS, the SIP serves as a commitment to specific measurable improvements in performance outcomes that the County is to achieve within a defined timeframe, including prevention strategies;

WHEREAS, El Dorado County Health and Human Services Agency (HHSA) worked in conjunction with the County of El Dorado Probation Department-Juvenile Services and other community partners to draft the County's SIP outlining child welfare strategies and goals for implementation to increase positive child outcomes, which covers the five-year period of April 17, 2022, through April 16, 2027;

NOW, THEREFORE, BE IT RESOLVED the Board of Supervisors of the County of El Dorado approves the 2022-2027 El Dorado County SIP for CWS/Probation which now incorporates the CAPIT/CBCAP/PSSF Plan for the five year period of April 17, 2022, through April 16, 2027 and authorizes the Chair to sign the Notice of Intent to contract with public or non-profit agencies to provide services in accordance with the CAPIT/CBCAP/PSSF section of the SIP;

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of El Dorado authorizes the Chair to sign the California – Child and Family Services Review Signature Sheet which identifies the HHSA Director (as the County Child Welfare Agency Director) and Chief Probation Officer as the County's leads in SIP administration; and

BE IT FURTHER RESOLVED that said Board of Supervisors of the County of El Dorado hereby authorizes the Health and Human Services Agency Director to approve SIP modifications and sign programmatic and financial reports as required by the State to ensure compliance with C-CFSR statutes and regulations.
