
Public comment. Re: Forebay Park

- Emails requested (page 2)
- There is no contract with the county...no promises. No project. It is a "wish list" of additions to an existing park. \$70,000 dollars collected without a contract, without a CEQA, and without a project.
- Emails, and the Mountain Democrat. "Harper said the El Dorado County Board of Supervisors will be advised that the commission has voted to make the Pollock Pines public playground the No. 1 priority for Parks and Recreation's 2021-22 budget.

Sanders said although this is only a recommendation, the community is thankful to the other Parks and Recreation commissioners for their acknowledgement of the underserved population of Pollock Pines and excited to finally be put on the front burner.

"Our greatest need is still raising money," said Sanders. "The priority of the Pollock Pines playground is a recommendation to the Board of Supervisors because there are so many different wish lists for all five of the districts in the county.
