ORDINANCE NO. 5095

THE BOARD OF SUPERVISORS OF
THE COUNTY OF EL DORADO DOES
ORDAIN AS FOLLOWS:

RELATED TO REZONING IN THE
SOUTH COUNTY/MT AUKUM AREA
(EL DORADO COUNTY):

Section 1. The Official Zoning Map for the South County/Mt. Aukum area is hereby amended to rezone the following described lands:

From: Timber Production (TPZ)

To: Forest Resource, 160-Acre (FR-160)

South County/Mt. Aukum Area:

Assessor's Parcel No. 040-080-06, being described as The Southeast Quarter of the Northwest Quarter of Section 12, Township 8 North, Range 14 East, M.D.M.

Also shown of record as Tract I of that certain Record of Survey recorded October 26, 1978 in book 6 of Official Records, Page 105, consisting of 45.25 acres.
