

**AGREEMENT FOR SERVICES #3524  
AMENDMENT II**

**This Amendment II** to that Agreement for Services #3524, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and New Morning Youth and Family Services, a California non-profit public benefit corporation, duly qualified to conduct business in the State of California (hereinafter referred to as "Contractor").

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide evidence and strength-based, culturally competent, flexible, individual-centered, family driven, effective, quality for Specialty Mental Health Services (SMHS) to all eligible individuals referred from the County, in accordance with Agreement for Services #3524, dated December 4, 2018, and Amendment I dated June 9, 2020, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the COVID-19 pandemic emergency has created many unique challenges to County of El Dorado mental health programs, one being an increased need for SMHS; and

**WHEREAS**, the increased need for SMHS has resulted in a deficiency to the projected funding identified in County Agreement #3524 with New Morning Youth and Family Services; and

**WHEREAS**, the parties hereto have mutually agreed to retroactively revise the maximum annual contractual obligation by service type, hereby amending **ARTICLE IV – Maximum Obligation**, to be effective November 1, 2020 ; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #3524 shall be amended a second time as follows:

1) Article IV is hereby amended in its entirety to read as follows, and will be effective November 1, 2020:

**ARTICLE IV**

**Maximum Obligation:** The maximum contractual obligation under this Agreement shall not exceed the combined total of the annual not-to-exceed amounts as set forth herein.

Contractor shall track amounts billed to County so as not to exceed the maximum obligation per fiscal year of the Agreement. In no event shall County be obligated to pay Contractor for any amount in excess of the maximum obligation per fiscal year of this Agreement.

Except as herein amended, all other parts and sections of that Agreement #3524 shall remain unchanged and in full force and effect.


