Dear Supervisor Parlin,



In addition Deer Valley's narrow evacuation roads are problematic.

We are requesting you deny these permits outright and stand up for our community.

We understand legal threats are a way to sway your judgment, but be assured we will also bring litigation to this matter.

I am writing to express my continued and strong opposition to the proposed commercial developments by HomeCA/Native Directions off Deer Valley Road.

First, I would like to personally thank Supervisor Parlin for standing firm on this matter and for your continued efforts to ensure these unsafe plans are not built. Your dedication to our community is greatly appreciated.

These centralized facilities do not fit in our community.
