5．A RROAD CLOSED＂sign shall be placed at each barricaded intersection．Each sign shall measura at least 48 inches by 30 Inches，with 8 infh black lefters on a white＿batkoround．
6．The organizens shall remove all signs，all pavement maraings or other materials immediately following the event．The organizers shall also rempya all debris deposited by participants and spectators．
7．The organtzers shall provide a Certificete of Lnatrance，naming El Dorado County Department of Transpatation additionally insured，in the emount of $\$ 1,000.000 .00$（onemillion dollers）as required by the EI Dorado County Risk Manager．
