ORDINANCE NO. 5108

**AN ORDINANCE TO ESTABLISH A SCHEDULE OF FEES  
FOR THE RECORDER-CLERK'S OFFICE**

**THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN  
AS FOLLOWS:**

**Section 1.** Title 3 – Revenue and Finance of the El Dorado County Ordinance Code is hereby amended by adding a new Chapter 3.25 pertaining to a schedule of fees for the Recorder-Clerk's Office to read as follows:

**Sec. 3.25.010 – Title.**

This chapter shall be known, and may be referred to, in all proceedings as the Schedule of Fees for the Recorder-Clerk's Office.

**Sec. 3.25.020 – Purpose.**

The purpose of this chapter is to establish a schedule of fees, authorized by law, in the amount reasonably necessary to recover the cost incurred by the County Recorder-Clerk on behalf of the County in providing the products or services enumerated herein.

**Sec. 3.25.030 – Authority.**

The fees established herein are authorized pursuant to the following statutes, as may be amended from time to time: California Business and Professions Code (B&P) §§ 6404, 6405(c), 17929(a), 17929(b), 17929(c), 17929(d), 22350, 22352, 22353, 22453 & 22453.1; California Civil Code (CC) § 8214; California Family Code (FC) §§ 360(c), 530-536; California Fish and Game Code (F&G) §§ 711 et. seq.; California Government Code (GC) §§ 12194, 26831, 26833, 26836, 26840.1, 26840.3, 26840.7, 26840.8, 26849.1, 26850, 26852, 26855.1, 26855.2, 26855.3, 26861, 27293, 27361, 27361.1, 27361(a)(2), 27361.2, 27361.3, 27361.4, 27361.8, 27361.9, 27366, 27372, 27387, 27388, 27388.1, 54985; California Health & Safety Code (H&S) §§103625(a), 103625(b)(1), 103625(c); and California Revenue and Taxation Code (R&T) §§ 408.3, 11911.

**Sec. 3.25.040 – Fee Schedule.**

**Sec. 3.25.050 – Statutory Fees.**

Fee amounts that are fixed by statute or adjusted by operation of state laws may be implemented by resolution of the Board of Supervisors.

**Sec. 3.25.060 – Severability.**

If any provision of this chapter, or any part thereof, is for any reason held to be unconstitutional, invalid, or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this chapter or any part thereof.


**Section 2.** This ordinance shall take effect thirty (30) days following adoption hereof.


