Recycled-content paper (paper towels, etc.): On September 27, 2016 (Resolution No. 8464), the City adopted an Environmentally Preferable Purchasing Policy (EPPP). The intent of the EPPP is to encourage and increase the use of environmentally preferable products and services in the City, whenever practical. For example, the City continues to purchase recycled paper products and implement EPPP throughout 2023.

☑ 1020-SR-BWR Business Waste Reduction Program	El Dorado Disposal (EDD) offers online bill pay for all customers for reduction of paper waste. EDD advertises free waste audits in their bi-annual newsletter. EDD offers free recycling to garbage service commercial accounts. EDD offers recycling free to commercial and multi-family Unit (MFU) accounts with garbage service. EDD utilized a "pay as you throw" rate structure. Commercial and MFU accounts pay more for larger garbage dumpster and more frequent pickups. In 2023, the Food Bank of El Dorado County and the Placer Food Bank continue to partner with local grocery stores that donate useable food to those in need throughout local area communities. EDD continued to implement AB 341 (Mandatory Commercial Recycling) and SB 1383 & AB 1826 (Mandatory Organics Recycling).
✓ 1050-SR-GOV Government Source Reduction Programs	The City has recycling programs for all City offices and facilities. EDD provided all City offices with mixed recycling collection receptacles. In 2020, mixed recycling receptacles were provided in Town Hall which is often rented out for group use. The mixed recycling material is consolidated at a mixed recycling bin for pick up by EDD. EDD provides free pickup of recyclable materials. City offices recycle confidential mixed paper through Shred City, a secure shredding company. All City offices have recycle bins for collection of recyclable materials (bottles, cans, etc.) The City surplus' furniture and office supplies for reuse by other City staff or other local government agencies and schools. Nearly all office supplies and furniture is reused. The City auctions off any unneeded surplus when available. Containers for collection of spent batteries are also available to City staff. City grounds maintenance staff accumulates green waste that is generated by maintenance activities at City park facilities and is composted at Lions Park or Gold Bug Park; or placed in green waste bins. The composted material is used by facilities for their maintenance projects throughout the City. Diversion quantities are unknown.
☑ 2030-RC-OSP Commercial On-Site Pickup	The City has mandatory commercial waste collection. Commercial customers are required to separate into one of two carts: trash and recyclables. Commercial food waste generators (such as restaurants & MFD's) are required to separate their waste stream into one of three carts: trash, recyclables, and organics. Dependent upon business type, a brown lid container may be offered or a green lidded container for all organic material. EDD's food-waste program includes provision of food waste only collection bins that has been collected and taken to Northern Recycling Compositing Facility located at the Yolo County Central Landfill.
☑ 2050-RC-SCH School Recycling Programs	EDD provides recycling service to all public school and private schools regardless of size, free of charge. All schools within the City of Placerville are taking advantage of this free program. The schools have significantly reduce their cost of service. EDD has met with the superintendents, principals, teachers, and janitors. EDD has provided blue cubes for use in the classrooms for ease of use for recycling. EDD has staff members trained to assist the schools with classroom curriculum and arrange for tours of the Materials Recovery Facility (MRF) at a time convenient to the individual classroom. EDD also participates in "Ag Day," focused on elementary school-age children. At this event children are introduced to composting and vermiculture. EDD mails information about their free education and recycling program to each school. The program includes tours of EDD's MRF and their composting / reuse garden. In 2023, EDD conducted MRF tours, truck tours, and school presentations on waste processing, recycling, and composting programs.



☑ 3020-CM-COG Commercial On-Site Greenwaste Pick-up	The City has mandatory commercial waste service. Green waste collection is offered with waste service. The green waste collected by EDD and transported to Yolo County Composting Facility to be composted and resold as soil amendment product. Most of the green waste produced on commercial properties are collected and self-hauled by a private landscape maintenance service company. The green waste material is taken to EDD's Diamond Springs Materials Recovery Facility (MRF) and then transported to Yolo County Composting Facility by EDD.
✓ 3030-CM-CSG Commercial Self-Haul Greenwaste	Commercial green waste self-haulers take material to the MRF in Diamond Springs. Green waste collected by EDD is taken to Northern Recycling Composting located at the Yolo County Central Landfill facility for composting.
☑ 3035-CM-COR Commercial Organics Recycling	Commercial food waste is mixed in with other organic waste at the MRF. This organic waste is currently taken to the Northern Recycling Composting Facility, a private operator leasing space at the Yolo County Central Landfill. Local grocery stores donate useable food to organizations such as the Food Bank of El Dorado County and Placer Food Bank for distribution to those in need throughout the county. Green Waste: Green waste is collected by EDD and taken to the MRF in Diamond Springs for storage and then hauled to the Northern Recycling Composting Facility in Yolo County.
☑ 3040-CM-FWC Food Waste Composting	EDD offers food waste recycling to commercial accounts. EDD takes food waste and other organics to the Northern Recycling Composting Facility, a private operator leasing space at the Yolo County Central Landfill.
☑ 3060-CM-GOV Government Composting Programs	City grounds maintenance staff accumulates green waste that is generated by maintenance activities at city parks where the material is composted at Lions Park or Gold Bug Park; or placed in bins for collection by EDD and taken to the MRF. The on-site composted material is used by facilities for their maintenance projects throughout the City. The El Dorado County Fairgrounds maintenance staff stores green waste generated from maintenance of the fairgrounds on-site for composting which is then used in landscaping.

☑ 1010-SR-BCM Backyard and On-Site Composting/Mulching	The City of Placerville does not have its own Environmental Management Department and refers calls received about home composting to the County Environmental Management Department (EMD). In early 2023 the City used CalRecycle Grant money (SB1383 Local Assistance Grant FY21-22 OWR1) to have education classes on home composting with Geobins. The City also offered classes on Vermicomposting. The classes were well received and we plan on continuing these classes in the future. The City maintains a "garbage,- recycling, and composting" webpage on its website: https://www.cityofplacerville.org/garbage-recycling-composting. Links are included to EMD's composting website: http://www.edcgov.us/Government/EMD/SolidWaste/Home_Composting.aspx. and El Dorado Disposal. The website provides links to numerous resources for residents who would like to learn how to compost including a localized composting guide that was created by the Regional Recycling Group. The guide provides "how to" descriptions on the various types of composting, troubleshooting, and a questions and answer section.
☑ 1060-SR-MTE Material Exchange, Thrift Shops	There are six thrift stores located in the City (Thrifted on Main, Grateful Threads, Violets Are Blue, Vintage Boutique, The Wild Pea Children's Consignment, and Sierra Consignment). There are two thrift stores located in close proximity outside the City limits. Snowline Hospice operates a large reuse program that continues to serve County and City residents located on El Dorado Road at U.S. Highway 50 and Goodwill Industries International operates a thrift store on Missouri Flat Road. El Dorado Disposal (EDD) plans to restart their textile recycling in 2024. EDD in conjunction with Cameron Park Rotary, provides for used bicycles that are pulled aside at the MRF and picked up by the local Rotary International. The rescued bicycles are then repaired and refurbished by Folsom Prison inmates and returned to the county to various charities that distribute the bicycles to those in need. Many of the bicycles come from the City and are returned to charities benefiting local children. Resident and businesses may take useable items to local thrift stores and Habitat for Humanity located in the community of El Dorado. The items are sold back to the community. Millwood Furnishings located east of Placerville and Habitat for Humanity accept useable C&D wood and furniture and resells that material back to the community. City residents and businesses are able to take their reusable C&D waste to Millwood Furnishings and Habitat for Humanity. Diversion quantities are unknown.
☑ 2000-RC-CRB Residential Curbside	Placerville has mandatory garbage collection and curbside recycling (City Code Title 7, Chapter 1A, Solid Waste Regulations), and has a franchise agreement with El Dorado Disposal (EDD) for services within the City. EDD utilizes a 3-cart system using green cans with color coded lids: black lids for trash/garbage, blue lids for recycling, and green lids for organic waste. EDD is implementing the residential food waste program in accordance with SB 1383. The program started with a pilot program in November 2021, and organics recycling has expanded to all residential customers starting January of 2022. Customers in the City have either a 64 or 96 gallon recycle cart with a second recycle cart offered to residents free of charge. Recycling is picked up every other week. EDD's side-load trucks have cameras in the hopper to monitor contamination. Residents are provided vouchers for free one-time pick-up of an appliance or a bulk waste item (items with Freon have an extra charge). In addition to cart service, EDD offers one-time per year curbside pick-up vouchers per year for: 1 bulk item, green waste. By appointment, EDD will pick-up curbside used oil/oil filters and household batteries. EDD has expanded curbside service offering bi-annual unlimited green waste collection. EDD uses education and notices to deter customers from placement of non-recyclables in curbside bins. EDD has prepared posters for all three waste streams (garbage, recycling, and food waste) available in the City offices and on the website. Offenders are provided a curtesy notice prior to enforcement.



☑ 2010-RC-DRP Residential Drop-Off	Residents may drop off metal, e-waste, HHW, florescent bulbs, cardboard, newspaper, plastic, household batteries, mattresses and bicycles free of charge at the EDD MRF in Diamond Springs. Residents are provided vouchers for free one time drop off of 2.5 cubic yards of debris or a bulk waste item (items containing Freon have an extra charge). EDD will levy extra fees on those residents that do not sort recycling materials prior to entering the MRF.
☑ 2020-RC-BYB Residential Buy-Back	EDD offers buyback for bottles and cans at three locations in the county: in Diamond Springs adjacent to the MRF, El Dorado Hills, and Cameron Park. The City has one privately operated buyback CRV recycling center, Town Clean Recycle Center located at 1770 Broadway.
☑ 3000-CM-RCG Residential Curbside Greenwaste Collection	The City has a mandatory waste collection. Customers are given a 96 gallon green waste cart by EDD with their mandatory waste service. An extra green waste cart is available to all residents free of charge upon request. Green waste is picked-up bi-weekly alternating with recycling. Residential food waste is disposed of in the green waste bins. Residential customers may place food waste in compostable bags. Curbside vouchers can be used for up to 2.5 cubic yards of green waste free collection at curbside. Residential green waste / food waste is taken to Northern Recycling Composting Facility at the Yolo County Central Landfill. Note: City residents have the option to burn their (yard) green waste on site on approved "burn days."
☑ 3010-CM-RSG Residential Self-haul Greenwaste	EDD provides a once per year voucher for free green waste drop-off up of up to 2.5 cubic yards at their Materials Recovery Facility (MRF) in Diamond Springs. EDD also donates vouchers and provides a discount to fire safe councils to eliminate organic wastes and limit the fire danger in the community.

✓ 5000-ED-ELC Electronic (radio ,TV, web, hotlines)	EDD, EMD, and the City maintains website and Facebook page to inform the public on collection events. EDD produces a bi-annual printed newsletter which is mailed with the local mail advertisements, distributed throughout the community, and posted on their website. The EDD and EMD websites contain information on recycling programs offered to county residents (includes City Residents) including, but not limited to: Buyback centers, AB 939, SB 1383, AB 341, AB 1826, C&D, Hazardous Household Waste collection events, used oil, waste tire amnesty, e-waste, paint, mattresses, green waste, composting, chipping, sharps, etc. Their website and Facebook page are regularly updated to inform customers of the latest news regarding recycling. This information is produced for both residential customers and commercial/MFU customers.
✓ 5010-ED-PRN Print (brochures, flyers, guides, news articles)	Informational brochures, pamphlets, and fact sheets on source reduction, recycling, and composting are distributed to the public by EDD. Welcome packets and annual waste guides are produced and mailed to each new customer and current customers including recycling materials which go to residential and commercial/MFD customers. Informational brochures and pamphlets are also available at the City offices.
✓ 5020-ED-OUT Outreach (tech assistance, presentations, awards, fairs, field trips)	EDD participated at the Home and Garden Show at the County Fairgrounds, Ag Day for schools. Other events are held outside the City limits and are available to residents and businesses whom are welcome to attend these events. At these events, EDD promotes their recycling and diversion programs and shares information on home composting, worm bins, community gardens and other types of recycling. EDD provides waste audits for their commercial and multi-family unit customers. EDD has an educational garden behind their main office on Truck Street for tours for any group interested in learning about gardening, water conservation, vermiculture, composting, and other types of recycling for benches, tires, bird feeders, etc. For construction and/or demolition projects, City staff informs.
	El Dorado Disposal provides an educational program and curriculum that promotes waste reduction and recycling. Tours of the Materials Recovery Facility (MRF) are provided for schools free of charge. EDD's MRF tour includes a look at their "upcycling" (repurposing something that would have otherwise been disposed of), composting/vermiculture garden.
	The County Environmental Management Department (EMD) and El Dorado Disposal (EDD) each advertised their HHW online: EMD:http://www.edcgov.us/Government/EMD/HazardousMaterials/Household_Hazardous_Waste_Collections_Facilities.a spx EDD: http://www.eldoradodisposal.com/MRF.aspx EDD also sends out information about their respective Hazardous Household Waste to their residential customers annually. Information is shared with the public at public events where EDD hosts a booth. The City provides links on its website for customers.

The City of Placerville does not have its own Environmental Management Department and refers calls received about home composting to the County Environmental Management Department (EMD). In early 2023 the City used CalRecycle Grant money (SB1383 Local Assistance Grant FY21-22 OWR1) to have education classes on home composting with Geobins. The City also offered classes on Vermicomposting. The classes were well received and we plan on continuing these classes in the future. The City has recycling programs for all City offices and facilities. EDD provided all City offices with mixed recycling collection receptacles. In 2020, mixed recycling receptacles were provided in Town Hall which is often rented out for group use. The mixed recycling material is consolidated at a mixed recycling bin for pick up by EDD. EDD provides free pickup of recyclable materials. City offices recycle confidential mixed paper through Shred City, a secure shredding company. All City offices have recycle bins for collection of recyclable materials (bottles, cans, etc.) The City surplus' furniture and office supplies for reuse by other City staff or other local government agencies and schools. Nearly all office supplies and furniture is reused. The City auctions off any unneeded surplus when available. Containers for collection of spent batteries are also available to City staff. Snowline Hospice operates a large reuse program that continues to serve County and City residents located on El Dorado Road at U.S. Highway 50 and Goodwill Industries International operates a thrift store on Missouri Flat Road. El Dorado Disposal (EDD) plans to restart their textile recycling in 2024. EDD in conjunction with Cameron Park Rotary, provides for used bicycles that are pulled aside at the MRF and picked up by the local Rotary International. The rescued bicycles are then repaired and refurbished by Folsom Prison inmates and returned to the county to various charities that distribute the bicycles to those in need. Many of the bicycles come from the City and are returned to charities benefiting local children. Resident and businesses may take useable items to local thrift stores and Habitat for Humanity located in the community of El Dorado. The items are sold back to the community. Millwood Furnishings located east of Placerville and Habitat for Humanity accept useable C&D wood and furniture and resells that material back to the community. Placerville has mandatory garbage collection and curbside recycling (City Code Title 7, Chapter 1A, Solid Waste Regulations), and has a franchise agreement with El Dorado Disposal (EDD) for services within the City. EDD utilizes a 3-cart system using green cans with color coded lids: black lids for trash/garbage, blue lids for recycling, and green lids for organic waste. EDD is implementing the residential food waste program in accordance with SB 1383. The program started with a pilot program in November 2021, and organics recycling has expanded to all residential customers starting January of 2022. Customers in the City have either a 64 or 96 gallon recycle cart with a second recycle cart offered to residents free of charge. Recycling is picked up every other week. EDD's side-load trucks have cameras in the hopper to monitor contamination. Residents are provided vouchers for free one-time pick-up of an appliance or a bulk waste item (items with Freon have an extra charge). In addition to cart service, EDD offers one-time per year curbside pick-up vouchers per year for: 1 bulk item, green waste.
