FIRST AMENDMENT TO FUNDING AGREEMENT #7475

THIS FIRST AMENDMENT to that Funding Agreement #7475 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and El Dorado Irrigation District, a special district created pursuant to State law, whose mailing address is 2890 Mosquito Road, Placerville, California 95667 (hereinafter referred to as "Applicant").

R E C I T A L S

WHEREAS, Applicant is responsible for fifty percent (50%) of the cost to prepare the Environmental Impact Report for the Project pursuant to Funding Agreement #7475, dated August 15, 2023 incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of August 14, 2026 for two (2) additional years, amending **ARTICLE III, Term**;

WHEREAS, the parties hereto desire to amend the Agreement to update the provisions of the California Levine Act, replacing **Exhibit C** with **Amended Exhibit C, Amended California Levine Act Statement**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Applicant mutually agree to amend the terms of the Agreement in this First Amendment to Funding Agreement #7475 on the following terms and conditions:

- I. **ARTICLE III, Term**, of the Agreement is amended in its entirety to read as follows:

ARTICLE III

Term: This Agreement shall become effective when fully executed by the parties hereto and shall expire on August 14, 2028, from the date thereof, or upon Project completion, or upon termination of the CEQA Consultant Agreement, whichever comes first.

- II. **Exhibit C, California Levine Act Statement**, is replaced in its entirety with **Amended Exhibit C, Amended California Levine Act Statement**, attached hereto and incorporated herein by reference. All references to **Exhibit C, California Levine Act Statement**, throughout the Agreement shall read, **Amended Exhibit C**.

Except as herein amended, all other parts and sections of Funding Agreement #7475 shall remain unchanged and in full force and effect.

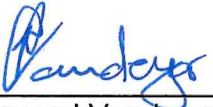

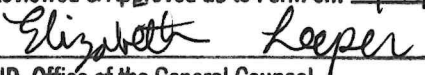

Amended Exhibit C

Amended California Levine Act Statement

California Levine Act Statement

California Government Code section 84308, commonly referred to as the "Levine Act," prohibits any officer of El Dorado County from participating in any action related to a contract if he or she accepts, solicits, or directs any political contributions totaling more than five hundred dollars (\$500) within the previous twelve (12) months, and for twelve (12) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract. The Levine Act also requires disclosure of such contribution by a party to be awarded a specific contract. An officer of El Dorado County includes the Board of Supervisors, any elected official, and the chief administrative officer (collectively "Officer"). It is the Contractor's responsibility to confirm the appropriate "Officer" and name the individual(s) in their disclosure.

Have you or your company, or any agent on behalf of you or your company, made any political contribution(s), or been solicited to make a contribution by an Officer or had an Officer direct you to make a contribution of more than \$500 to an Officer of the County of El Dorado in the twelve months preceding the date of the submission of your proposals or the anticipated date of any Officer action related to this contract?
