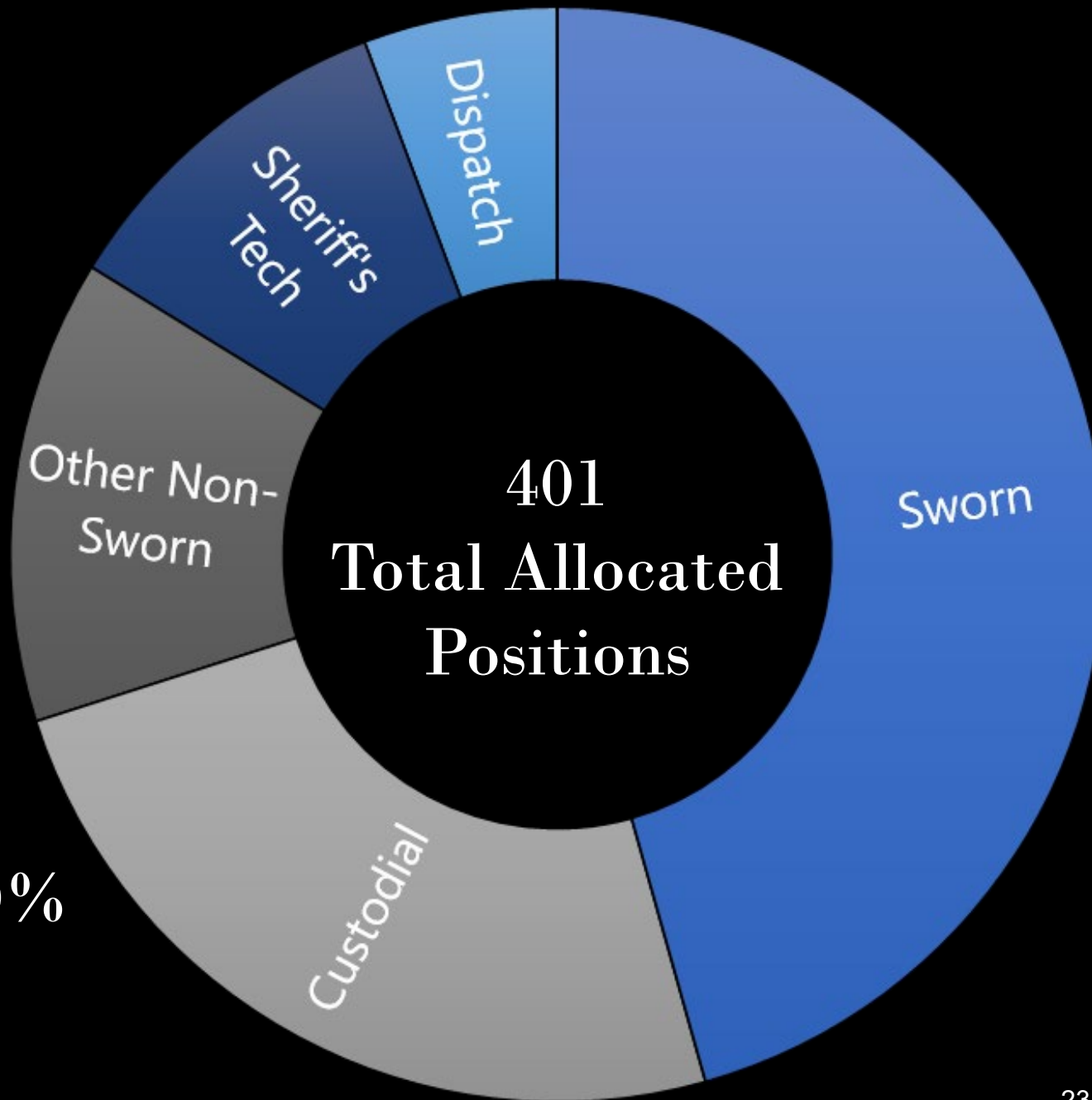

Detectives attended various community education and outreach events

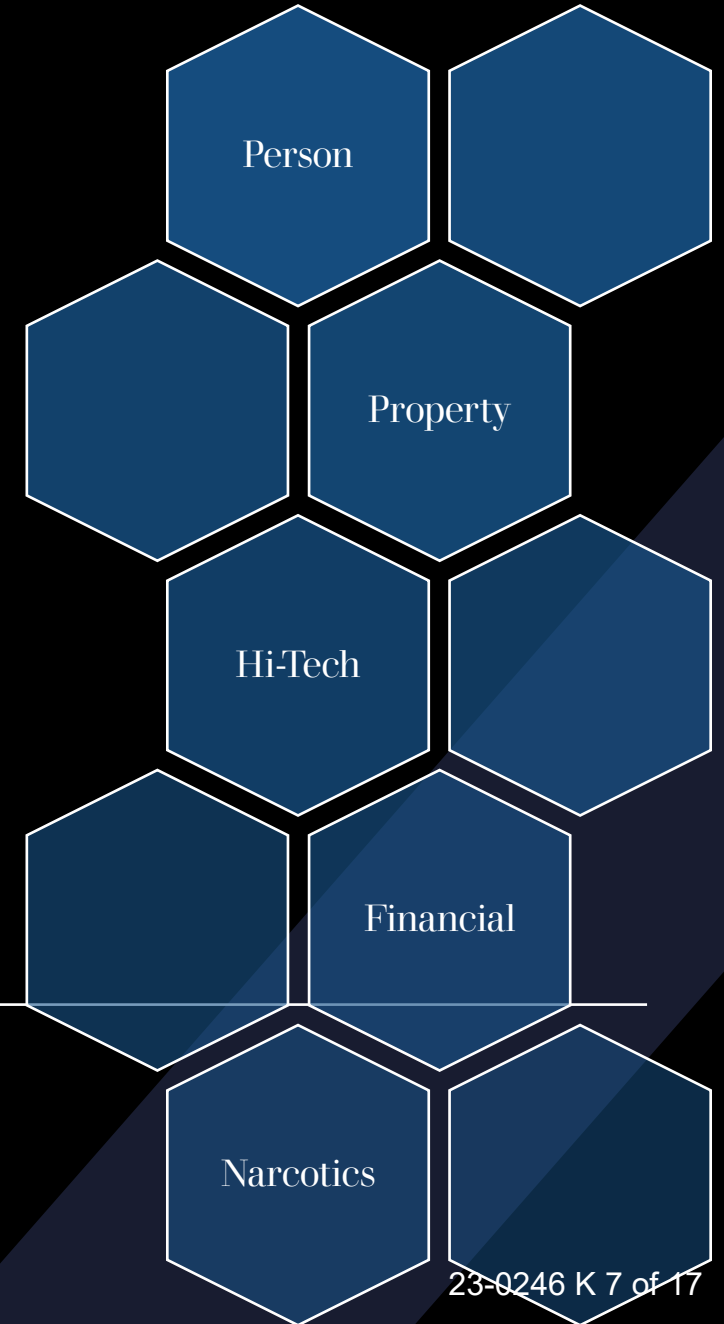

The Sheriff's Office of Emergency Services works cooperatively with regional agencies to prepare and respond to acts of violence, community threats and natural disasters

Coordinates the 130 Search and Rescue Volunteers who responded to 115 rescue missions in 2022

Three EOC Activations while continuing to coordinate Wildfire Recovery efforts

Includes off-road support including Off-Highway Vehicles, Motorcycles, Marine Unit, Dive Team and Unmanned Aerial Systems to supplement Patrol Operations

Jail expansion project for the recovery, rehabilitation and re-entry project continuing. The 23,000sqft wing will add new medical and mental health services and programs.

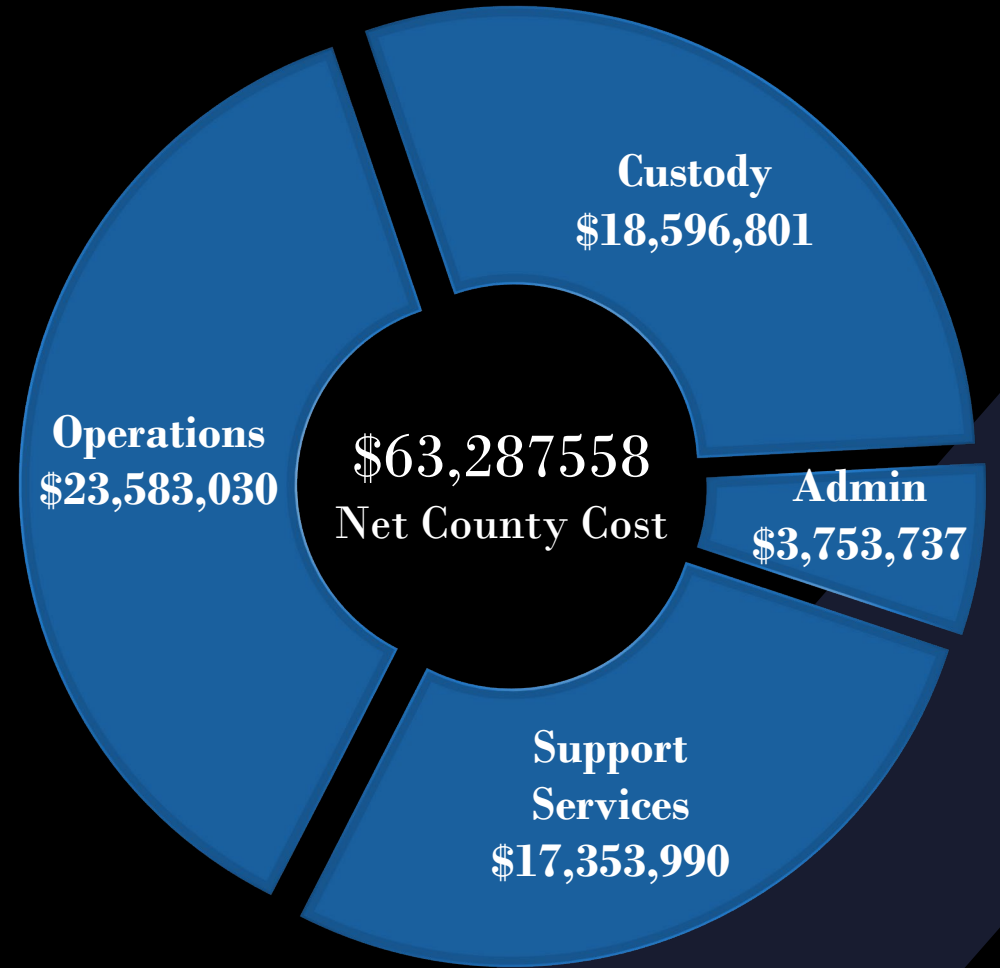
Support Services
