Chief Administrative Office recommending Board authorize Chairman to sign a Memorandum of Understanding (MOU) between the Judicial Council of California, Administrative Office of the Courts (AOC), Superior Court of California, and the County of El Dorado regarding the funding mechanism for the Juvenile Court Project in the space under the Placerville Juvenile Hall.

**FUNDING:** Courthouse Construction Funding.
