Please accept the following input for the planning and operation of the proposed Grocery Outlet:

1. Improve building aesthetics. Specifically, require more architectural variation on the front elevation. Adding properly placed awnings and pergolas would greatly improve the look. The proposed design does present a nice neighborhood market, but rather a scaled down big box store. This location deserves a nice looking neighborhood market, not just a box with an entrance structure.

2. Add operational restrictions to disallow the storage and sales of items outside the store. Including, propane tanks, ice freezers, vending machines, pallets of water, etc, and any other non-seasonal item.

3. Landscape must include undulations, rock outcroppings and native trees (live and blue oaks) so the store looks like El Dorado Country.

4. DOT- Improve the turn at Green Valley Rd and Cameron Park Drive. Currently, there is not a turn lane from eastbound Green Valley to Cameron Park Drive- confusing slashed out area only.
