Dear Supervisors,

While it is personally disappointing to me that the Cameron Park census designated place is the only one of the 12 census designated places in El Dorado County\* to be split in both final redistricting maps, I heartily endorse "Revised B" as the best redistricting alternative of the 2 final maps as "Revised B" keeps the "percent difference" for all five districts within the range -1.51% to +1.38%.

It is to Staff's credit that none of the other tweaks requested on November 16<sup>th</sup> made it into "Revised B" as none of those suggested other tweaks adhered to the mandated priority parameters of the Fair Maps Act (other than the transfer of 798 suburban population in Rescue within the Cameron Park census designated place and done so in order to level population between Districts 2 and 4).

I do request that Staff maintains in its files that map alternatives developed for 2031 redistricting start with ensuring that all census designated places are not split. In hindsight the 2021 redistricting would have progressed far more smoothly if up front attention to census designated places had been followed.

I also would like to comment about the suggestion by some for El Dorado County to use an independent commission to do supervisorial redistricting. I believe a separate redistricting commission is a very BAD idea as redistricting requires both: a) diligent efforts by County GIS and legal staff, AND b) every step of the way public scrutiny of those doing redistricting, both of which occurred in your 2021 redistricting.
