 - Crisis training for police and sheriff
- Received 1,700 calls in 2018

HOMELESS OUTREACH TEAM

Under Sheriff Randy Peshon

<u>PURPOSE</u>

To serve incarcerated individuals with mental illness in efforts to reduce jail population.

- Officers receive training in dealing with mental illness and addiction and operate crisis intervention teams.
- Officers develop relationships with homeless individuals, monitor them and refer individuals to county and private resources.

THE LIGHTED CANDLE

Peter Brown

PURPOSE

To provide relief to the homeless community. Work to remove the stigma of homelessness. Highlight the individual's humanity and challenges of reentering society.

OFFER:

- Portable laundry facilities
- Mobile showers
- Free garbage services
- Employment assistance

FAMILY RESOURCE CENTER

Bill Martinez

- Operates after school and summer programs to educate youth regarding the environment, forest service and wilderness.
- Works with Mexican consulate and pro-bono lawyers to provide a pathway to citizenship for minority families.

COMMISSION ON AGING

Lisbeth Powell

PURPOSE

To assess issues and challenges of seniors in EDC, including:

- elder abuse
- lack of technology know-how
- the right to be useful
- housing needs
- fair education
- support of family
- independence
- the right to die with dignity

30% of EDC individuals are over 60 years of age: 45% of those are low income

CIVIL RIGHTS NOW

Mike Saunders

PURPOSE

Social justice actions with the purpose of diminishing racist incidences in EDC

(Example: a 12-year-old who approached an African American man in a local supermarket calling him the n-word)

Promote education:

Donated African history books to the EDC Public Library

African Americans represent 1% of EDC population

TEMPLE KOL SHALOM

Dale Wallerstein

PURPOSE

A Jewish congregation which enjoys learning, holiday activities and social and worship opportunities with our diverse community.

Congregation concerns:

- Attacks on synagogues and cemetery defacements nationwide
- Fear of local violence and abuse
- Media representation (especially Mt. Democrat)

Congregation interventions for safety:

- Use of first names only on congregation roster
- Lock door before services
- Work with local law enforcement to ensure safety measures

EL DORADO COUNTY PUBLIC DEFENDER

Teri Monterosso

PURPOSE

Offers legal representation to those who cannot afford private representation.

- Provides assistance in interpreting and navigating a legal system that is not designed to accommodate special needs (mental illness 30-40% of jailed population), elderly, veterans, and physically disabled.
- Cost of jailing an individual is \$30-\$40K.
 Cost of keeping an individual out of jail is \$10K.
- Job of PD could be supported with social workers.

OFFICE OF EDUCATION

Ed Manansala, County Superintendent of Schools

- 38,400 K-12 students in EDC
- Of 186,500 residents, 4377 live in poverty
- 13% of school aged students are non-English speaking
- 91% of seniors graduate from local HS programs
- 65% of seniors in foster care graduate from local HS programs
- 64 students were arrested
- 1147 students are homeless ("unstable living situation")
- Services are fragmented / centralized services and communication is needed

El Dorado Community Foundation Bill Roby

- The Community Foundation works to ensure the highest participation in the 2020 census.
- The county has a high rate of hard-to-reach communities including minorities and migrant workers.
- In 2010, EDC had an 80% reporting rate / 50% in the Tahoe area.

CURRENT GOALS OF COMMISSION

- GOAL 1: Make a commission report to BOS ASAP.
- **GOAL 2:** Commission members will participate in a 4-hour strategic planning meeting facilitated by a local leader.
- GOAL 3: Collect data on human rights violations (concerns) in EDC.
- **GOAL 4:** Develop a communication source to post community Human Rights activities, events and information and strategies to drive traffic to it.
- GOAL 5: Develop an active working relationship with community members/agencies/organizations to accomplish Goals 3 and 4.
- GOAL 6 Begin planning a second forum.
