Greetings El Dorado County Board of Supervisors:

I would like to express my wholehearted support for the Sheriff's Substation being organized in the Safeway shopping center in Cameron Park. My name is Bill Glasser and I am the managing partner of the Burke Junction Shopping Center. I really am pleased that the Sheriff's department and the El Dorado County BOS are organizing resources to make this a reality.

As many of you know, there has been a noticeable uptick in property crime in our community. Also I am to understand that the Quality Inn motel located across the street from the Safeway Shopping center, is currently being used to temporarily house parolees and formerly homeless people. Some of these individuals may not be receiving adequate follow-on support services, which could account for what many residents have identified as lost souls perambulating the streets and getting into trouble.

For all these reasons, Cameron Park businesses such as our family-owned small businesses who rent space at Burke Junction, are shouldering an inordinate share of policing the public nuisance of these circumstances. With the new Sheriff Sub Station proposed, I believe we will have support and shorter response times should a situation in our community warrant an intervention by professional law enforcement.

#### Board-

Cameron Park citizens have been experiencing a decline in the sense of safety and security when shopping in the primary economic center of the community for several years now.

The Sheriffs substation being placed in this location is a positive step in the right direction to mitigate the ongoing thefts, property crimes, loitering and other challenges this center faces. We are also seeing an increase in neighborhood thefts, prowlers and other crime spilling into our community and hope this will provide a deterrent to those activities as well.

As this Board is aware, there is a disproportionate use of combined social and mental health services in the hotel directly across from the proposed location. The Sheriff's presence will bring a renewed sense of security to the area and hopefully mitigate some of the illicit activity and visual blight. It is also the hope that the known drug activity in the parking lot will be reduced or deterred given the visual presence of the Sheriff.

As a citizen who patrons this specific center, I have personally witnessed and observed an increase in individuals who are visibly on drugs and behaving in a manner which is intimidating and unsettling for my young children and the significant elderly population in my neighborhood. I have spoken to many of the business owners who have expressed their inability to rent or lease their commercial buildings due to a reduced sense of safety and security at this location and the immediate surrounding area. Our economic center is declining and we feel unsafe.

As citizens, we look forward to having close proximity access to the Sheriff's office and hope to utilize the station community center to organize and meet with our new neighborhood watch program. We are also hopeful that the Sheriff's HOT team will be able work in and around the new substation so that we, as a community, may continue to learn how to be effective partners in and around Cameron Park.

Thank you for considering this item and the feedback from the citizens of Cameron Park. We are very excited about this prospect and are looking forward to having public safety resources embedded into our town center similar to our neighbors in El Dorado Hills.

Dear members of the El Dorado County Board of Supervisors,

I am writing to express my support for the Sheriff substation in the proposed location of the Safeway Shopping Center on Coach Lane in Cameron Park.

I have lived in Cameron Park for almost 28 years. During this time, I have personally witnessed the increase of crime in the Safeway area and in our subdivision. I have also found myself in uncomfortable situations while shopping at Safeway in the evening hours due to suspicious behavior of people that are loitering in the parking lot to the extent that I no longer shop there. As I drive along Coach Lane in the evening hours to and from my subdivision (which is behind Safeway), I frequently encounter people walking or loitering in the roadway or coming to or from the Quality Inn, who appear to be under the influence of some substance as demonstrated by their actions of being oblivious to blocking access to vehicle traffic as they stroll along or across the street or their erratic behavior. I have also come upon people sleeping on the ground behind Safeway. Upon speaking with a couple of the store managers in the shopping center, they bemoan the fact that they are tired of people loitering or sleeping in their store front areas and at least one I've spoken with is considering leaving.

I feel having a substation in this location will be a deterrent to crime just by having a presence in our community. Being located across from the Quality Inn will hopefully help to keep paroles and their visitors and other people from gathering in the Safeway parking lot. It will also give residents local access to services at the substation. It's presence will provide the extra security that will enable residents to safely access businesses in the area during day or night time hours. Thank you.
